

## **Lopez Sex Harassment Report Due for Release**

The New York State Ethics Board says it will soon release its report about accusations that Assemblyman Vito Lopez sexually harassed young female staffers.

The state Joint Commission on Public Ethics report is now in the hands of the Legislative Ethics Commission, which could take action against Lopez.

Assembly Speaker Sheldon Silver approved a \$103,000 settlement, paid with public money, last year to settle some of the harassment claims against the 71-year-old Lopez, a once powerful Brooklyn Democrat.

Lopez has denied the accusations.

Lopez continues to serve in the Assembly, although he was stripped of his leadership posts and stipends.

## Catsimatidis Gives \$5K to Parade

Brooklyn Daily Eagle Republican mayoral hopeful John Catsimatidis showed his support for the Kings County Memorial Day Parade by showing up at a parade committee fundraiser in Bay Ridge on April 28 and pulling a \$5,000 check out of his pocket.

Catsimatidis was joined by his wife Margo and Assemblywoman Nicole Malliotakis (R-C-Bay Ridge-Staten Island) as he presented the check to Parade Committee Chairman Ray Aalbue at the Salty Dog Restaurant and Bar on Third Avenue.

The parade, which is in its 146th year, will be held on Monday, May 27, starting at 11 a.m. The parade route begins on Third Avenue and 87th Street and ends in John Paul Jones Park on Fourth Avenue and 101st Street, where a wreath-laying ceremony will take place. Soldiers at the nearby Fort Hamilton Army Base will give a 21-gun salute.

The parade, the oldest continuously run Memorial

Day Parade in the U.S., has been held in Bay Ridge for the past 20 years. Prior to that, it was held on Eastern Parkway. The event is sponsored by the United Military Veterans of Kings County and Borough President Marty Markowitz.

Due to decreased government funding, local leaders, musicians, and the parade committee have joined together for an annual fundraiser to ensure the parade has the resources to continue, Aalbue said.

## **A Foundation for** Affordable Housing **In New York City**

Everywhere we look, New Yorkers are being squeezed. Prices keep going up, while a recent report shows that 46 percent of everyone in the City lives in poverty or very close to it.

This squeeze is especially true when it comes to housing. By one measure, one-third of all New Yorkers spend half their total income on rent. And while luxury condos continue to spring up, rents for everyone are on the rise, affordable apartments are disappearing, and working and middle class families are finding it harder to stay in their neighborhoods.

It truly seems like New York City is becoming more and more "A Tale of Two Cities." We need a new direction when it comes to housing in New York City. We need a foundation to make quality housing affordable again for families.

New York used to build for the middle class. From Astoria to Flatbush, the homes and apartments that were constructed years ago were built for teachers, nurses, officer workers and firefighters. This approach formed the backbone of working and middle class neighborhoods across the city.

But that's not the way we build anymore. Under the Bloomberg Administration, the housing policy has emphasized one-bedroom and studio apartments in lower Manhattan, instead of larger units that can sustain families in the Bronx or Queens.

We need to stop the affordable housing crisis. That means putting tenants ahead of big developers, and using untapped resources that could get shovels in the ground on affordable apartments and homes. The plan I've put forward, "Foundation for an Affordable City," does just that, and commits us to build and preserve nearly 200,000 affordable housing units over the next eight years.

For starters, we need mandatory rules that guarantee affordable housing to accompany changes to development rights or zoning rules.

We need to put underused land and vacant lots to work for our neighborhoods. As a Brooklynite, few things are as frustrating as seeing lot after empty lot in communities desperate for new affordable housing. It's time to close tax loopholes that incentive keeping land empty, so we can jumpstart affordable development here and now.

With new reforms, we can also start improving thousands of substandard apartments outside the current marketplace. It's time to bring converted basement apartments and granny flats into the light of day and under the protection of our housing code. That means safer housing for those already living in those units, and a green light for landlords who want to create new affordable units by converting part of their building.


There is more. I want to invest \$1 billion from our pension funds to invest in quality, affordable housing. We need to take back control of our rental laws from Albany. There is no reason why politicians upstate should be dictating to us our rental policies. And we need to stand up for tenants who are being mistreated, and help good landlords continue to improve their properties and access to affordable housing.

Taken together, these reforms represent a new vision - a new foundation on how we approach housing in New York City, and how we can make housing affordable for working and middle class families in every borough. ## Schools' Data-Sharing Program Outrages Parents

Student Info Already in Cyberspace

Parents called the Department of Education's move to share confidential data about their kids with private corporations "outrageous," "contemptible" and worse at a highdrama town hall at Brooklyn Borough Hall Monday night.

The outrage level only got higher after families learned that the city had already handed their children's personal information over to inBloom Inc., a Gates-funded corporation, which plans to share students' information with for-profit vendors to help them market "learning products."

"Our children have a right to privacy," declared Monique Lindsay, a Coalition for Educational Justice leader. "Only we as parents have the right to share their information with anyone. We will do whatever it takes to stop inBloom, Bloomberg, and anyone else. How dare they think they can share our children's information with anyone?"

Sally Sinisgalli, a Queens mom, said, "Why do they have to know my ethnicity and my child's hair and eye color? I don't write about or put a picture of my children on Facebook."

The student data being shared includes names, addresses, emails, photos, grades, test scores, learning

styles, disciplinary, health and attendance records, the results of academic and psychological tests, and more.

According to the inBloom website, teacher and staff data are also being collected, along with incidentals such as what type of documentation parents presented to confirm a child's identity and the nature of the student's home environment.

Leonie Haimson, executive director of educational nonprofit Class Size Matters, organized the town hall and produced a presentation. Representatives from inBloom were invited to attend, but did not show up – drawing hisses from the crowd.

Reportedly, information is being collected from as far back as 1996 and is being stored on an Amazon cloud built by Wireless/Amplify, owned by Rupert Murdoch's News Corporation – a company still facing litigation for violating the privacy of individuals in Great Britain and the U.S.

"This is thoroughly disgusting," said Natasha Capers, a representative of the Alliance for a Quality Education and a District 23 parent. "It's no one's business how many absences my child has and my contact information. I just got an email from Amazon saying my security was breached."

Stephen Boese, representing the Learning Disabilities Association of New York State, said the organization's members were "very concerned."

"When someone has a learning disability, it's their right to disclose that disability – not the right of a third party. There's still a lot of stigma, a lot of discrimination," he said, adding that some children have committed suicide when their personal information got out "into the cybersphere."

Boese said the group wrote a letter to State Education Commissioner John King, but received no response.

Adina Lopatin, the Department of Education's deputy chief academic officer, said the data sharing does not violate the Family Educational Rights and Privacy Act (FERPA), which protects the privacy of student education records.

When parents asked who will be responsible when "the inevitable" data breach takes place, she said the state would bear responsibility

Lopatin said the city DOE would be dropping its \$80 million ARIS system, which currently stores student data and instructional resources, and that a new statewide Education Data Portal would add "functionality over time at a lower cost.

"The state is using inBloom, which will create data structures according to a common set of standards," Lopatin said. She said that a vendor would not be able to access that data unless the district or state has a contract with that vendor – a statement that drew derision from the crowd.

When asked by parents if the data could be used for anything other than educational purposes, she replied, "It would be possible to use it for other purposes, but we have no current plans to do so." She also

confirmed that parents would not be able to "opt out" of the database.

As parents shouted out comments, moderator Margaret Kelley, education liaison to the Brooklyn borough president, urged courtesy and warned, "If this gets out of hand, I'm going to have to adjourn this forum."

## NYC: Citi Bike Will Generate \$36M in Economic Activity

## Brooklyn Facilities Play Integral Part

New York City Department of Transportation (DOT) Commissioner Janette Sadik-Khan on Tuesday announced Citi Bike is expected to create 170 jobs and generate \$36 million in local economic activity annually.

NYC Bike Share (NYCBS) has worked with a wide range of community and local employment organizations to recruit New Yorkers for positions from station assemblers to bicycle mechanics to customer callcenter staff.

These new hires will support the operation of 6,000 Citi Bikes at 330 stations in the initial service area, which includes streets south of 59th Street in Manhattan and ad-

jacent neighborhoods in Brooklyn. These 170 permanent positions will contribute an estimated \$36 million to New York City's economy each year as wages are spent and invested locally.

When the system expands to 10,000 bikes, Citi Bike is expected to fill dozens of more permanent positions, with all jobs paying competitive hourly wages.

The system is supported without taxpayer subsidy by \$41 million in sponsorship from Citi, \$6.5 million from MasterCard and financing from the Goldman Sachs Urban Investment Group. NYCBS is using the Goldman Sachs financing to purchase the equipment, stations and other ongoing capital requirements.

"Even before New Yorkers kick the tires of the Citi Bike fleet, bike share is kick-starting employment with jobs for New Yorkers," said Commissioner Sadik-Khan. "Citi Bike will help New Yorkers reach their destinations quickly and make more neighborhoods, businesses and jobs more accessible."

To support Citi Bike, NYCBS recently leased more than 39,000 square feet of space in Sunset Park, Brooklyn. The site will serve as the bike-share system's main facility and headquarters, with dedicated space for repairing the bicycles and a call center for user support.

The company also currently rents a 77,000-square-foot warehouse with another 43,000 square feet of lots in Greenpoint, Brooklyn, where components are being assembled into stations

ready for deployment on city streets. NYCBS already has hired 170 employees to assist with the system's roll out and related operations. Areas of responsibility include community outreach, bicycle assembly and maintenance, station and IT technology, and administration, management and finance.

"Not only does Citi Bike offer New Yorkers a fun and healthy way to get around, it is also providing a boost to our local economy," said City Councilman Stephen Levin, who represents Greenpoint. "I am excited about the launch of Citi Bike and equally excited that the working people and small businesses of New York City will benefit as well."

## **What Happens Next at LICH?**

Just last Friday SUNY Downstate, in a stunning reversal, withdrew its closure plan for Brooklyn's Long Island College Hospital (LICH). But that doesn't mean the hospital is out of the woods.

To update the community and discuss the next steps, the Cobble Hill Association is hosting a community forum on the future of LICH. The forum takes place Thursday, May 2, at 7:30 p.m. at LICH, 339 Hicks St., Conference Room A.

Attendees also plan to do a little celebrating, Cobble Hill Association (CHA) President Roy Sloane said in a statement.

"We have a lot of people to thank and a lot of work that remains to be done. We sincerely hope you'll be able to join us for this next, most important phase of the battle to save our hospital." The panel discussion will feature just a few of the many people and organizations who have been working around the clock to save LICH, which serves a swath of Brooklyn from Red Hook to Williamsburg. On the list are Assemblywoman Joan Millman, Councilman Brad Lander, Matthew Bethel (policy director for Sen. Daniel Squadron), Concerned Physicians of LICH, and Michelle

Greene of the NYS Nurses Association. More panelists may be added, CHA said.

Months of protests, letter-writing campaigns, meetings with state officials and court action led to SUNY's withdrawal of the plan, which it had earlier submitted to the state Department of Health, to close LICH.

Although the SUNY board voted to close the 150-year-old hospital in March, Brooklyn Supreme Court Justice Johnny Lee Baynes issued a temporary restraining order on April 1 that barred the state from shutting down LICH pending a May 2 hearing.

Last Thursday, City Council members voted unanimously in favor of a resolution calling on SUNY and the Department of Health to work with stakeholders to find another operator for LICH.

#### The Great Film the Music Hall Refused to Run

MANHATTAN — Citizen Kane, remarkable for, among many things, Gregg Toland's deep-focus black-and-white photography, premiered at the RKO Palace Theatre in Manhattan on May 1, 1941. Radio City Music Hall had declined to book it. Reviews of the film had appeared since March

On March 1, Welles had threatened to sue both William Randolph Hearst if the press baron was successful in his efforts to have *Citizen Kane* suppressed, and RKO, if it did not finally release the film. The picture lost \$160,000 on its initial release.

On January 8, 1941, Hearst had instructed his newspapers not to take any ads from RKO in retaliation for its impending release of *Citizen Kane*. The film was widely understood to be a thinly veiled portrait of Hearst

## 'Catch-22' Author Heller Born in Coney

Joseph Heller was born in the Coney Island section of Brooklyn on May 1, 1923, the son of Isaac Donald Heller, who drove a delivery truck for a wholesale baker, and Lena Heller. The father died of complications from a bleeding ulcer when "Joey" was five. His mother raised her family as best she could, taking in boarders. Joey gained a reputation as a smart aleck adept at delivering acerbic one-liners and a great believer in playing practical jokes on his friends. His mother used to tell him, "Joey, you got a twisted brain."

Heller attended P.S. 188 and spent a typical Coney Island-type boyhood in shenanigans on Surf Avenue. He loved to read the "Tom Swift" and "Rover Boys" books. When he was about ten, an older cousin got him to read a child's version of Homer's "Iliad" and that is when he decided to become a writer. He graduated from Abraham Lincoln High School in 1941. Heller worked during his school years, delivering telegrams. His aspiration was still to become a writer and he wrote some short stories that were published and well received.

Heller's first job was as a blacksmith at the Norfolk Navy Yard in Virginia. At the outbreak of World War II he enlisted in the Army Air corps. He did this with some of his Brooklyn friends, who made a grand gesture of taking the oath of enlistment in Grand Central Terminal

Heller went to a cadet school and became a bombardier, flying on 60 missions. He rose to the rank of lieutenant. After the war he took advantage of the G.I. Bill of Rights to attend the University of California and later New York University. His education continued with his earning a master's in literature from Columbia, winning a Fulbright scholarship and studying at Oxford University in England in 1950.

Returning to the U.S. he taught at Pennsylvania State University, worked for *Time* magazine in advertising from 1952 to 1956 and did the same thing for *Look* magazine from 1956 to 1958. He also worked for *Mc-Calls* magazine and in the advertising department of Remington Rand Typewriters.

Through these years he continued to write and his stories were published in Esquire, Atlantic Monthly and Cosmopolitan. It took Heller eight years to write Catch-22. Based on his experiences as a bomber pilot, the title Catch 22 has become the term used to mean a bureaucratic runaround that is a common feature in modern society. The phrase is now an integral part of American lingo. The novel is an absurdist, antiwar black comedy that became a best seller. The film version made in 1970 starred another Brooklynite, Alan Arkin, as the reluctant pilot, Yossarian. Heller's later writings include the novels Something Hap-

pened ('74), Good as Gold ('79), and God Knows ('84), as well as an account of his battle with Guillain-Barré syndrome (debilitating depressive disorder), No Laughing Matter ('86).

To all his work, Heller brought the sort of street-smart insights and wiseguy attitudes he gained as a boy on the streets of Brooklyn—an experience he describes in his 1998 memoir *Now and Then: From Coney Island to Here* 

Heller's reputation as a lovable grump with a quick stinging wit apparently was well earned. In his later years it is said that he showed signs of becoming a softie. When he contracted the debilitating Guillain-Barré syndrome in 1981, he was nearly paralyzed and feared the remainder of his days would be spent as an invalid.

But he fought back, gained strength, and fell in love with one of his nurses, Valerie Humphries, who became his second wife. Heller had divorced his first wife, Shirley Held, in 1984. They had a daughter, Erica, and a son, Ted.

Joseph Heller died of a heart attack December 12, 1999, at his home in East Hampton, where his wife, Valerie tried unsuccessfully to revive him.

Asked once what his biggest fears were, Heller replied: "I fear death, nursing homes and vaccinations.

But he came to grips with death, he said, explaining: "Everyone else seems to get through it all right so it couldn't be too difficult for me."

"There was only one catch and that was Catch-22, which specified that a concern for one's own safety in the face of dangers that were real and immediate was the process of a rational mind. Orr was crazy and could be grounded. All he had to do was ask; and as soon as he did, he would no longer be crazy and would have to fly more missions. Orr would be crazy to fly more missions and sane if he didn't, but if he was sane he had to fly them. If he flew them he was crazy and didn't have to; but if he didn't want to, he was sane and had to."

## Nets Are Stayin' Alive vs. Bulls

## Brooklyn Passes Major 'Gut' Check in Game 5

It's quite possible that the Nets learned more about themselves during what was by far the most devastating playoff loss in franchise history than at any other point during their historic first season in our fair borough.

After suffering through a heartbreaking Game 4 collapse in Chicago, during which it squandered a 14-point lead before limping off the United Center floor with a gut-wrenching triple-overtime defeat, Brooklyn bounced back in courageous fashion Monday evening before another "Blacked Out" crowd at Downtown's Barclays Center.

Whether it was Joe Johnson draining a pair of game-tying jump shots on one good leg in Saturday's devastating 142-134 loss or the news that the Bulls thought the Nets were "gutless and heartless," our borough's first major pro sports franchise since the beloved Dodgers fled to Los Angeles was not yet ready to say Goodbye Playoffs.

"I believed that we would respond," Nets interim coach P.J. Carlesimo insisted amid reports that his job status likely hung on the outcome of this best-of-7 firstround series. "We've bounced back

all year too well, and as disheartening a loss as that was on Saturday, there's still been enough good minutes in this series. Neither of us is getting away from each other."

Carlesimo went so far as to play a video of a Chicago beat reporter intimating to the nation that the Bulls were happy to draw the Nets in Round One. Unnamed Chicago players claimed Brooklyn might lack the intestinal fortitude to stay the course in what promised to be a grind-it-out battle for the right to face the defending NBA champion Miami Heat in the Eastern Conference semifinals.

Deron Williams, the Nets' \$98 million point guard and undisputed floor leader, scoffed at the notion that the Bulls' questioning of his teammates drive and desire was what precipitated Brooklyn to a convincing 110-91 triumph in Game 5.

"Every game is an elimination game. Every game is the most important game from here on out," stated Williams, who scored 23 points and handed out 10 assists in Brooklyn's first-ever win-or-go-home game before the home faithful. "What were we supposed to do [after watching the video]? Get mad? We knew we had to win this game."

Angered or not, the Nets, to a man, gave everything they had in

All-Star center Brook Lopez continued to elevate his status as arguably the best big man in the NBA, pouring in a game-high 28 points and ripping 10 rebounds, including six off the offensive

Reserve pivotman Andray Blatche put up 13 points, including 10 in the fourth quarter, as Brooklyn finally pulled away from the pesky Bulls, who were without injured point guard Kirk Heinrich.

Even C.J. Watson, who gained Bill Buckner-like infamy for missing a wide-open dunk that could have sunk Chicago in Game 4, showed great resilience off the bench with 11 points and four rebounds in 23 effective minutes.

Johnson, still dealing with the plantar fasciatis that has limited his explosiveness, hit 5 of 11 attempts from the floor en route to 11 points while logging what had to be a painful 39 minutes.

## Fight to the Finish

## Garcia Survives Epic Barclays Bash with Brooklyn's 'Super' Judah

Danny "Swift" Garcia remained unbeaten after successfully defending his unified lightweight titles for a third time with a unanimous decision victory over Brooklyn's own Zab "Super" Judah on Saturday night before a vociferous crowd of more than 13,000 fight fans at Downtown's Barclays Center.

The 25-year-old Phladelphian also learned an extremely valuable lesson during the third, and by far most exhilirating, night of championship boxing on the corners of Atlantic and Flatbush Avenues: Never underestimate a tried and true warrior when he's down.

Garcia, who dominated most of the 12-round bout, floored Judah with a vicious straight right in the eighth round. That led many in the crowd to believe the 35-year-old former five-time world champion in two weight classes was on his way to the latest in a series of unimpressive defeats to superior opponents.

But buoyed by the hometown crowd, and perhaps his own sense of ring mortality, the fighter formerly known as the "Brooklyn Flash" summoned up the energy to take it to his younger adversary. Judah rocked Garcia in rounds 10 and 11 before the two bloodied pugilists fought valiantly to the bell in Round 12.

"Whoo! It was a hell of a fight!" Garcia expouring off his face following the announcement that he had taken the decison by scores of 115-112, 114-112 and 116-111.

"I had to beat the Brooklyn guy in his hometown," added Garcia, whose ever-present father and trainer, Angel, breathed a sigh of relief after his son improved to a perfect 26-0. "I knew he had a lot of pride behind him and he was never going to give up. He is a crafty veteran with power. He hit me with a good shot. He hit me in the eleventh with a left hand that spun me around. It shook me up a little bit."

These words of praise for the elder statesman were genuine after months of trash-talking between the fighters, including a pair of nasty runins at the pre-fight press conference and Garcia's appearance at the Modell's across the street from the arena in the days leading up to the fight.

"I am a true champion and I had to fight through a storm tonight to prove that," added Garcia, who improved to 2-0 in Downtown Brooklyn after opening the state-of-the-art arena with an impressive fourth-round knockout of Mexican boxing icon Erik "El Terrible" Morales last October. "Judah is the craftiest and strongest guy that I have fought so far. I knew he had a lot of power with the left, but I was able to stand my ground and counter it. My game plan was to try to use the jab, but he was stepping around. He was crafty and he took my jab away so I had to do what I had to do."

"You're going to see me fight again," he added defiantly. "Why would I quit?"

The Eagle scored the first round even and gave the fighters a split of rounds two and three before Garcia took command. He powered his way through fourth to ninth rounds with a series of straight and overhand rights, landing the occasional uppercut and left hook before Judah mounted his unexpected late comeback.

After staving off Judah's final assault, Garcia was asked whether the real blood on his face had replaced the bad blood the fighters had built up in anticipation of the fight.

In defeat, Judah, fighting with a deep gash on his left cheek, proved that he was worthy of yet another big bout, even if his chance at going down as one of boxing's immortals continued to elude him.

"It's boxing and things happen," Judah said. "You win some, you lose some. Danny is a young, tough fighter. I was on my A-game tonight. I worked hard. I had a great training camp and we gave it our best shot."

"It's gone," Garcia admitted. "It's respect. As you can see, it's a lot of bad blood. I've got cuts. He has cuts. We came here and gave the people of Brooklyn a nice show."

Garcia vs. Judah was preceded by another championship bout featuring New York native Peter Quillin, who successfully defended his WBO Middleweight World Championship for the first time with a seventh-round TKO of a very game, but ultimately overmatched Fernando Guerrero.

Donning a Red Sox cap on his way to the squared circle to honor the victims of the Boston Marathon bombing, Quillin (29-0, 21 KOs) scored three knockdowns before his overhand right sent Guerrero sprawling to the canvas for the fourth and final time at 1:30 of Round 7.

"It's the journey that is the most important," Quillin said of his latest triumph. "I have to thank Fernando for coming up, but he couldn't do it. I had to do it for New York City. I'm inspired by my team. It's always working to try to do your best. I was working hard to do my best. I put myself through a hard training camp to try to come to this fight and try to look like superman. The sky is the limit."

Also on Saturday night's undercard, Brooklyn's "Miracle Man" Danny Jacobs (25-1, 22 KOs), a cancer survivor on his way up the middleweight ranks, scored a fourth-round TKO over Kennan Collins. Brooklyn's Luis Collazo (33-5), Boyd Melson (10-1-1) and Zachary Ochoa (4-0) also scored easy wins.

Bensonhurst native and WBA welterweight champion Paulie Malignaggi, who was on hand for Saturday night's bouts as part of SHOWTIME's broadcast team, announced that he would headline the fourth big boxing card at Barclays on

"The Magic Man" will take on two-diviion champion Adrian "The Problem" Broner ir less than two months in what is being billed a matchup between two of the sport's mouthiest fighters.

"I wanted be in a huge main event at Barclays Center," said Malignaggi, who was in the co-feature fight in the original Barclays boxing card back in October. "This is a blockbuster event and I can't wait to make a successful title defense in Brooklyn where my roots are."

"Paulette better be in some shape," jibed Broner. "On June 22, I will be a three-time world champion in three weight classes at just 23-years-old."

As we learned in the Garcia-Judah showdown Saturday night, talk is cheap when it comes to big fights in the heart of Downtown Brooklyn.



## More People Filing Wage-and-Hour Lawsuits; **Brooklyn Federal Court Sees Huge Increase**

Federal courts around the country are seeing a rise in the number of lawsuits filed for wage and hour violations. Of the 94 federal districts nationwide, the Eastern District of New York (which covers Brooklyn, Queens, Staten Island and Long Island) ranks fifth, and the Southern District (comprised of Manhattan, the Bronx and Westchester, Rockland, Orange, Dutchess and Putnam counties) ranks third.

Between 2003 and 2012 the number of filings for wage and

hour complaints have steadily increased. According to the Federal Judicial Center statistics, in 2003 there were 6,727 civil filings in the Eastern District, with only 57 being wage and hour suits. In 2012 there were 6,580 civil filings in the Eastern District, and 579 of these filings were wage and hour complaints.

Despite a decrease in total civil filings the rate of wage and labor suits is accruing.

The Federal Labor Standards Act is a federal law that established the 40-hour workweek. minimum wage, and guaranteed overtime for certain jobs. In order to bring a FLSA action, one would have to show that an employeeemployer relationship existed, that the FLSA applies to the employeeemployer relationship, and that some aspect of the FLSA was violated. Once a purported employee is able to establish these three elements, the burden is on the employer to disprove the asserted

If an employee wins a FLSA claim, they are entitled to their unpaid compensation in addition to the potential to recover their attorneys' fees. The award increases if the FLSA violation was willful.

"If an employer fails to keep accurate time records, that in and of itself is deemed willful," Jeffrey Gottlieb, a founding partner of Gottlieb & Associates, told the New York Law Journal.

New York state's six-year statute of limitations, the increased public awareness and the possibility of a high award have been cited as reasons for the increase.

**Bloomberg Staunchly** Defends Stop-and-Frisk

In a pugnacious defense of what he called a police force bombarded by politics, Mayor Michael Bloomberg lashed out Tuesday at critics of the New York Police Department's stopand-frisk practice and surveillance pro-

"The NYPD is under attack," the mayor said in a speech that lauded the department for lower crime rates, raised the specter of terrorism and excoriated supporters of legislation that

would rein in stop-andfrisk. He also was critical of legal groups that have sued over the practice, mayoral candidates whom he didn't name and the media.

'Stop playing politics with public safety. Look at what's happened in Boston. Remember what happened here on 9/11. Remember all of those who have been

killed by gun violence and the families like criminals and are tainted with they left behind," Bloomberg said. 'We owe it to all of them to give our officers all the tools they need to protect innocent lives or people will needlessly die, and we'll all be responsible."

It was a message the mayor has sent before, amid an ongoing federal civil rights trial over stop-and-frisk and City Council hearings to set new rules for the tactic. He also has repeatedly embraced the NYPD's surveillance and other counter-terror programs after a series of stories by the Associated Press on the department's widespread spying on Muslims.

But the 22-minute speech and setting — at police headquarters, in front of a room full of uniformed

telegraphed stepped-up, aggressive response to those who question whether the nation's largest police department has overstepped its bounds.

Some were quick to push back. Public Advocate Bill de Blasio, one of the Democrats seeking to succeed Bloomberg next year, called the mayor's speech "fear-mongering" that "offers a false choice between public safety and our basic constitutional

Stop-and-frisk — the practice of

stopping, questioning and sometimes patting down people seen as doing something questionable but not necessarily meriting arrest has become a flashpoint as the stops rose dramatically in the last decade. to nearly 700,000 in 2011. They dropped to 533,000 last year.

Critics say the stops

treat innocent people racial profiling, noting that more than 80 percent of those approached are Council proposals toward a vote.

black or Hispanic; these groups make up 54 percent of the population. Civil rights and minority advocates and some lawmakers also see the tactic as ineffective because more than 85 percent do not result in arrests or weapons being confiscated

The mayor has long insisted the stops are based on suspicious behavior, not racial bias, and are a powerful tool for curtailing crime.

The demographics of those stopped reflect not racism but statistics, as a great majority of crime suspects are black or Hispanic, he said Tuesday. And where critics see a dearth of weapons being found, he sees a deterrent.

There is no doubt that stops are a vitally important reason" why New York has lower rates of major crimes than other big American cities, he said.

The stops have spurred protests, have become a must-address issue for mayoral candidates and have engendered the ongoing federal trial and negotiations propelling the City



City Council Speaker Christine Quinn — the Democratic front-runner in the mayor's race — is supporting a measure that would create an inspector general to look at the NYPD's policies and procedures. She said last week she opposed but wouldn't block a vote on a proposal that would make it easier for people to sue over stops they felt reflected racial profiling.

Bloomberg, often seen as a key potential supporter for Quinn's mayoral bid, blasted both proposals. He said the lawsuit proposal would "allow New York state judges to micromanage the NYPD" and an inspector general could muddy policy for officers and make other law enforcement agencies reluctant to share information with the NYPD, for fear the inspector might have

Quinn said in a statement that she agreed the lawsuit proposal would encourage frivolous claims but felt the inspector general was needed to balance preserving safety with promoting stronger relations between police and
