Good morning. Today is the 203rd day of the year. On this day in 1902, the Brooklyn Daily Eagle reported on the demand for a second subway tunnel from Brooklyn to Manhattan. The first tunnel, the route of the present-day 4 and 5 trains, was already in the planning stages, and the city had awarded the contract to the Interborough Rapid Transit Company (IRT). The Brooklyn Rapid Transit Company (BRT) was asking the city to build a subway tunnel of its own to link some of its trolley and surface transit lines, which it planned to rebuild, to Manhattan. But Judge Issues Last-Minute Order To Keep Hospital Open

In a dramatic turn of events, Public Advocate Bill de Blasio on Friday successfully petitioned a judge for a Temporary Restraining Order (TRO) blocking Long Island College Hospital's immediate closure, despite a letter from the state Department of Health approving SUNY Downstate's closure plan.

De Blasio planned to personally serve LICH administrators with the TRO at 5 p.m. on Friday, supported by State Sen. Daniel Squadron, Assemblyman Joan Millman, Council Members Brad Lander and Stephen Levin and other elected officials.

Supreme Court Justice Johnny L. Baynes issued the TRO on the grounds that de Blasio's filing demonstrated the "immediate and irreparable injury if Respondent's [Downstate's] actions are not temporarily restrained until a hearing on a preliminary injunction, adding that Downstate's actions demonstrate "disregard for the Court's orders and may interfere with protection of the status quo."

Justice Baynes wrote that SUNY Downstate is immediately restrained "from taking any action or issuing any order that would interrupt, hamper or curtail medical professionals duly employed by or working within LICH from providing medical care, including emergency medical services." He also forbid Downstate from diverting ambulances or patients from the hospital, as Downstate has been doing for weeks.

Immigrant Politician Who Made Good Praises City's Policy on Immigrants

Calling it a "hallmark achievement for our city," City Council candidate John Lisyanskiy, who emigrated from the Ukraine to the United States two decades ago, praised the city's

new \$18 million program to as-

sist undocumented immigrants.

Lisyanskiy is running in the Democratic primary for the council seat in the 47th District, representing Coney Island, Gravesend and parts of Bensonhurst. The seat is currently held by Democrat Domenic Recchia Ir who is term-limited and can-

not run for re-election.
"In 1992, I emigrated here

with my family from the Ukraine. I began my career in politics because I believe strongly in democratic government and I am proud that our city has taken this groundbreaking step to protect immigrants. The process of citizenship is not easy, and I believe we can make it better through programs like this," Lisyanskiy, a financial analyst in the City Council's budget division, said.

The New York Daily News reported on July 17 that the city plans to spend \$18 million over the next two years helping undocumented immigrants get jobs, driver's licenses and Social Security cards.

City Council Speaker Christine Quinn announced the plan on Wednesday. Under the plan, the city will build 16,000 adult *Please turn to page 2*

'Diceman' Enjoys a Comic Rebirth

Clay Was Known for Being 'Politically Incorrect'

Brooklyn-raised comedian Andrew Dice Clay is on a roll. Or as the comedian sees it, enjoying a resurgence.

Clay, who grew up in Sheepshead Bay and went to James Madison High School and Kingsborough Community

College, is in Woody Allen's latest movie, "Blue Jasmine." He will judge a new syndicated TV talent show and see his autobiography published next spring, and is collaborating on a documentary about his life and career with "Entourage" creator Doug Ellin.


Add to that his guest shot on "Entourage" in its final season in 2011 and last December's Showtime standup special, "Andrew Dice Clay: Indestructible," and it sounds like a comeback for Clay, 55, after a fallow period that included a brief 2009 stint on "Celebrity Apprentice."

Clay, who got his start at the now-defunct Pips Comedy Club on Emmons Avenue, looks at it otherwise.

"I've always done things a little differently," said Clay, who became both popular and polarizing in the 1980s with his profane, raw standup routines, especially those with women as the topic.

Clay was so controversial—so misogynistic, angry detractors said—that his 1990 appearance as "Saturday Night Live" host prompted boycotts by series cast member Nora Dunn and scheduled musical guest Sinead O'Connor.

New York State Nurses Association Executive Director Jill Furillo sent out words of thanks for the TRO, calling SUNY's move to close LICH "reckless."

"SUNY has created a healthcare meltdown in Brooklyn putting patients at extreme risk during an extreme heat wave.

Earlier on Friday, SUNY Downstate had revealed a letter from DOH allowing financially troubled Downstate to close LICH, a Cobble Hill hospital it took over two years ago.

According to the letter to Dr. John Williams, president of Downstate, LICH would "cease admitting patients from its Emergency Department (ED) at noon on July 22, 2013," and transfer all remaining patients by July 28. The letter went on to say that LICH would continue to operate its ED with all supportive ancillary services, including laboratory, radiology, social work and pharmacy, until July 29, 2013.

Elected officials called DOH's approval of the closure plan "a terrible mistake."

"By allowing SUNY to mothball LICH before a new operator is in place, DOH's decision undermines a long-term healthcare solution for the community and Brooklyn," said Sen. Daniel Squadron. "There are solutions for LICH, and significant interest from potential operators — but the state and SUNY have come together to undermine those, instead of working collaboratively to make them a reality.

Friday morning, de Blasio announced that he was filing the action in Brooklyn Supreme Court to block the clo-

Over the past couple of weeks, Downstate has closed core departments at LICH, transferred all but 18 patients and diverted ambulances from the Emergency Room, causing overcrowding and long delays at ERs across Brooklyn.

With de Blasio on the podium at the noon rally on Friday were Deputy Borough President Sandra Chapman, representing Borough President Marty Markowitz; state Sen. Daniel Squadron, Assemblywoman Joan Millman, Councilwoman Letitia James, Councilman Brad Lander and several LICH employees. A crowd of supporters gathered across the hospital, chanting "Save LICH!" and other slogans and cheering as cars honked their horns. Some of their chants taunted Gov. Andrew Cuomo, whom up until now has been silent on the issue.

One neighborhood woman, Anna Ruggiero of Union Street, said she has been coming to the hospital for more than 50 years. Speaking about the diversion of ambulances to New York Methodist, she told the Eagle, 'The other day, I saw an ambulance (heading to Methodist) stuck behind traffic on Union Street for 20 minutes.'

Many of the protesters wore

departments: Emergency, Case Management, Radiology. Kenneth Goudoras, one of those employees, said. 'This is one of the best hospitals in Brooklyn."

Assemblywoman Millman told the Eagle, "It's a disgrace. They're pulling out patients, putting them onto ambulances and taking them to other hospitals, risking their lives. The other day they took out a man on dialysis and drove him to

Squadron led the protesters in a chant, referring to the almost-daily protests: "Were you here yesterday?" "Yes!" "Are you here today?" "Yes!" "Will you be here tomorrow?" "Yes!"

Meanwhile, anger in the communities served by LICH grew. John McGettrick, head of the Red Hook Civic Association, said, "It's clear the closing of the hospital would have a serious impact on Red Hook. Asked about whether it would be quick for ambulances to get from Red Hook to New York Methodist, he answered, "That depends on the time of day, and whether the Hamilton Avenue drawbridge is up." He accused the SUNY board of being more concerned with real estate than with healthcare.

Roy Sloane, president of the Cobble Hill Association, told the Eagle, "It seems to me that in all my years of watching condos being put in our parks and our libraries being sold, the actions of the SUNY Downstate administration in terms of creating this artificial most craven, irresponsible and

House Passes Velázquez Education Proposal

The U.S. House of Representatives passed a measure authored by Rep. Nydia M. Velázquez (D-Brooklyn) that would enhance educational services for children in low income and working families. The proposal was approved yesterday and included in a larger education reform bill that passed the House Friday.

"A solid education can open the doors of opportunity for children," Velázquez noted. "It is vital we invest the resources to ensure all families, regardless of background, can provide their kids with tools they need to succeed in life."

Velázquez's proposal would target resources to families that are often hardest to reach and face the greatest challenges in securing an education. The overall bill harnesses the power of community-based organizations to engage parents and create a better educational environment for students by establishing Family Engagement Centers. The proposal authored by Velázquez would ensure there are specific plans in place to assist working and low income families.

"Many immigrant, low-income and working families in New York simply don't have the resources other parents do when it comes to supporting their child's education," Velázquez noted. "Under my proposal, we will ensure federal education assistance goes to the families that need it most, so that all children can benefit from a quality education.'

Studies show a continued education performance gap between affluent and lower income areas. Non-minority students also enjoy advantages over minority students, leading to a gap in graduation rates.

Across New York State, the graduation rate for white students is 28 percent higher than it is for black and Hispanic students. Although 94 percent of students from wealthier "low needs" areas graduate high school, only 65 percent of children in lower income, "highneeds" districts receive their diploma.

"A quality education should be a basic right in this country, regardless of a family's income, race or ethnic background," Velázquez added. "Only by working to correct the inequalities in our educational system can we ensure all of our children have an opportunity to succeed

The education bill passed by the House must now be reconciled with Senate legislation to update our school system before being sent to the President for his approval.

He hasn't lost his onstage edge, still essaying the Diceman persona that he calls the "ultimate rock and roll standup comedic hero," one that's equal parts swagger, black leather and middle-age pompadour. But Clay suggests that the culture is so altered that it's caught up with him, putting him in a different light.

Women "have become the aggressors, ne said. When i say they're the most aggressive piglets ever, I don't say that with disrespect. I waited for this generation."

In conversation, Clay is so polite that before he introduces a racy thought he assures the listener that it's part of his onstage material not rudeness

He's eager to talk about his sons, Max, 22, and Dylan, 18, who Clay says took center stage in his life after he went through a divorce about a decade ago. Both boys are pursuing entertainment industry careers and, together, have a band called L.A.

"I felt it was really more important to raise my sons properly than make career moves." Clay said. "I did the clubs, did theater, but didn't make any kind of moves to have this resurgence until they were old enough."

The Diceman as devoted dad?

"My persona is one thing. Who I am off stage as a human being is really different," said Clay. He's a relative newlywed, married three vears to Valerie Vasquez. 29 ("I'm crazy about her").

Allen spotted him on "Entourage," Clay said, leading to his role as a divorced blue-collar dad in "Blue Jasmine." which has been singled out by some critics (Variety called him "an especially offbeat and rewarding casting choice").

Clay, who's pursued both acting and standup, was so delighted by the chance to work with Allen and beside stars Cate Blanchett and Alec Baldwin that he agreed to let his hair go gray for the part.

"I said, 'You don't have to ask me twice. I'll hate it, but if it's good for the movie I'll do it," Clay recounted.

Next May, he's set to co-produce and judge "The Big Big Show," which Clay calls a cross between "American Idol" and "The Gong Show," and which will include his buddy Tom Green on the panel.

Also scheduled for spring 2014 is his autobiography, "The Filthy Truth," from Simon & Schuster and co-authored by David Ritz, who's written books with Ray Charles, Etta James and Don Rickles.

Clay just keeps going with the rollercoaster ride.

"It's just been in me since I was young. I've never given up on who I am, I've never forgotten where I come from, Brooklyn, N.Y., or how I was brought up. My fighter inside me, my belief and my drive, never goes away.'

seeking to defer deportation, adding to the 20,500 who have already been granted this privilege. In order to qualify, immigrants must have either a high school diploma, a general educational certificate, or must currently be enrolled in school.

In addition to the adult education classes, the city will also pay for a pilot program to create the nation's first public defender system for immigrants facing deportation. The \$18 million project is the largest investment made by any city in the country

to help immigrants obtain a deferral from deportation, Lisyanskiy said. Congress, which has yet to

pass comprehensive immigration reform, should take a page from New York, according to Lisyanskiy. "While our city works to protect our diverse population, our federal government remains stagnant to pass comprehensive immigration reform. While today's plan will help 16,000 residents, there are hundreds of thousands more who need our help," he said.

"I urge cities across our country to echo this breaktion nationwide. My parents came here for a better life, and today 16,000 more Ne ers will begin on a path to citi-

An Italian Grows In Brooklyn

GRAVESEND — Jerry Della Femina, born on July 22, 1936, grew up in the Gravesend section of Brooklyn. He graduated from Lafayetter High School and attended Brooklyn College. In one of his books, his autobiography, An Italian Grows in Brooklyn, Jerry refers to a Prince Macaroni commercial that shows a young Italian kid in Boston running home for lunch on Wednesday. Jerry can recall the only time he came home early for lunch was when he got caught by a teacher playing craps in the hallway of Lafayette High School and ran in the Gravesend sechome to get himself organized. tion of Brooklyn. He talked his mother into giving him money for a haircut so the

teacher wouldn't recognize him when he returned to school the following day.

Other bittersweet memories of growing up in the predominantly Italian neighborhood included the "football" weddings, stickball games on West 10th Street, and the P.S. 95 schoolyard hangout.

Jerry did not achieve success overnight. In 1954 he started looking for an advertising writer's position. After holding 32 different jobs, from messenger boy to shipping clerk. Della Femina finally was hired as a copywriter in 1961.

In 1967 Jerry co-founded his own agency, and after a merger in 1988, became chairman of the Della Femina, Mc-Namee WCRS Agency. The agency is noted for its brash, creative energy, and has produced commercials that featured Dom Deluise (ZipLock Bags) and the "ever truthful" Joe

Jerry is married to TV newsperson Judy Licht. He still finds time to visit the old neighborhood and says that it has "stood still in time."

Designer of 'Great Bridge' Dies

John Augustus Roebling, the brilliant engineer who designed the Brooklyn Bridge, died on July 22, 1869.

Roebling contracted tetanus after his foot was crushed by a ferryboat at the Fulton ferry slip in Brooklyn on June 28, 1869, where he and his son were surveying the site for the Brooklyn tower of the bridge.

After his toes were amputated, Roebling refused any conventional medical treatment, believing that pouring water over the wounds would cure them (a belief known as hydropathy.) He suffered immensely for several weeks before succumbing to the infection. The muscles in his face and neck became increasingly rigid, and his face locked into a haunting grimace.



On July 22, 1934 America's first-named Public Enemy No. 1, John Dillinger, was shot dead by FBI agents as he left the Biograph movie theater in Chicago. Even as he lay on the undertakers slab he fascinated the American public.

He was unable to speak or eat, yet his mind remained clear, entombed in his failing body. He reportedly wrote notes regarding his medical care and the bridge right up to the end.

John Roebling was born in Germany in 1806 and acquired his Civil Engineering degree from the Royal Polytechnic Institute in Berlin, where he also studied under the eminent philosopher Georg Hegel. Roebling came to the United States in 1831, and after a brief stint as a farmer, embraced his true calling. His projects before the Brooklyn Bridge included a railroad bridge over the Niagara River, a railway suspension bridge over the Kentucky River and a suspension bridge over the Ohio River in Cincinnati. He also became quite wealthy as a wire manufacturer in

The Brooklyn Bridge was, of course, his crowning achievement, although he didn't live to see it become anything more real than a design on paper Roebling's son Washington bling, took over as chief engineer of the bridge, although he himself was also soon struck with serious illness. While working within the compressed air of one of the bridge tower's caissons (a compressed air foundation) beneath the East River, Washington contracted "the bends." For the rest of the bridge's construction, he was bound to his bed and would send instruction to the site through his wife Emily. He was able to oversee construction from the window of his home on Columbia

The bridge was the longest in the world when it was built, which alone would have secured the opinion that Roebling was a genius. But the roadbed also had to run high enough to allow for river traffic, with its tall ship masts, to pass below. The height of the two river banks were of no help, being of a naturally low elevation, as opposed to say, a cliff, which would have made the job easier.

So, adding to its greatness, the bridge's two gothic towers were taller than most any building in New York at the time (only the spire of Trinity Church in Lower Manhattan was higher.). They were some of the largest manmade structures on the continent.

Part of what was revolutionary in Roebling's design was the use of steel wire as opposed to iron. Steel had not yet proven itself as the reliable building material we know it to be. The tension of these steel cables, with the profusion of smaller suspender cables radiating off of them to connect with the bridge floor, not only creates one of the most beloved and notable aesthetic features of the bridge, but also much of its stability.

"The way he designed it, the enormous structure was to be a grand harmony of opposite forces — the steel of the cables in tension, the granite of the towers in compression," wrote historian David McCullough in his book The Great Bridge.

'A force at rest is at rest because it is balanced by some other force or by its own reaction," Roebling had once written.

While it was being built, many New Yorkers were incredulous as to the bridge's stability, since a structure of that magnitude had not been a part of anyone's experience.

But many years later, John Augustus Roebling's design holds strong and is one of the city's most iconic and beloved structures, which probably would not have surprised its de-

He was quoted as saying in 1869, two years before his

'The completed work, when constructed in accordance with my designs, will not only be the greatest bridge in existence, but it will be the greatest engineering work of the continent, and of the age.

'Its most conspicuous features, the great towers, will serve as landmarks to the adjoining cities, and they will be entitled to be ranked as national monuments.

'As a great work of art, and as a successful specimen of advanced bridge engineering, this structure will forever testify to the energy, enterprise and wealth of the community which shall secure its erection."



Protecting Interest Rate On Student Loans

Congress has been inflicting a lot of pain on the country over the past several years, but rarely has it been as glaring and destructive as its failure to prevent the interest rate on student loans from doubling. A college education is already beyond reach for many Americans; with Congress' failure to act on this problem, the cost is only going to rise even higher.

The Republican House and Democratic Senate and President Obama are all at odds over the best approach to hold down those interest rates, which had been at 3.4 percent. Democrats say the House plan balances the budget on the backs of students, while Republicans note that the Senate hasn't done anything at all.

A solution appeared in sight last week with a tentative agreement that seemed to give both sides some of what they wanted. But a Congressional Budget Office estimate that it would cost \$22 billion over 10 years scuttled the plan.

Unless Congress acts before students return to their schools this fall, the rate increase on subsidized Stafford loans could mean an extra \$2,600 for an average student, according to Congress' Joint Economic Committee.

One possible solution is that Congress will kick the can down the road by renewing the expired system for another year.

That would be better than nothing, though a permanent fix is also required. Such a fix would require Washington to take a completely different approach to the issue. For guidance, it can look west to Oregon and even farther west to Australia.

The Oregon Legislature has proposed an "investment approach" to student loans. Tuition at public universities would be free, but students would agree to pay 3 percent of their earnings for the first 25 years after graduation. Those who earn very little would pay very little, perhaps much less than the cost of their educations. Those who make a lot of money could end up subsidizing the system, but still earning enough money to make it palatable.

It's an interesting approach, based on a system that Australia adopted nearly a quarter-century ago. There, repayments are based on student income as recorded by tax authorities. It's a voluntary system that most students there choose. The repayment can reach as high as 8 percent of income, according to Inside Higher Ed (www.insidehighered.com), but only when incomes top the U.S. equivalent of \$35,000 a year.

The plan has been successful enough that it has been copied in New Zealand, South Africa, the United Kingdom and Hungary. Other countries, including Ireland and Malaysia, may soon follow.

In 2007, the federal government adopted a law that was meant to have a similar effect. Called Income Based Repayment, it ties some students' repayments to their income, but it also requires constant monitoring. Marriage, divorce, childbirth, promotion, job loss and other life events need to be documented to the government. Just qualifying for the program is complicated, and confusing rules have held down participation.


Oregon and Australia appear to be on to a better idea. The Oregon Legislature and governor's office are in Democratic hands, but the vote in both chambers of the Legislature was unanimous. Nathan E. Hunt, one of the students who proposed the plan, told the New York Times that the approach appealed to conservative members "because it's a contract between the student and the state, so they see it as a transaction, not as a grant."

One of the points of our federalist system is for the states to act as laboratories in which good ideas can bubble up to other states, and even Washington. Oregon is bubbling with a great idea that has been successfully tested in many other countries. Washington should take a look.

See Federal Court Bias in Civil Rights Suits

It's no secret that many federal judges do not like basic tort cases dealing with false arrest and imprisonment — especially where the NYPD is involved.

So, for the past two years, under a special program instituted by a group of jurists in the Southern District, the plaintiffs' bar has endured severely restricting discovery rules severely the curbing rights of plaintiffs which are protected at the state court level.

At the same time, the new judge-initiated rules generously grant the municipality extended time limits on filings and discovery especially regarding cases brought in Manhattan and the Bronx.

Plaintiff's lawyers seemed powerless to stop this new "parallel" system of justice.

Personal injury and civil rights lawyers think this system should be done away with. "I find the present plan profoundly disturbing," attor-

ney Joel Rudin wrote *The New York Times*. "It makes the Southern District a hostile forum for plaintiffs."

Unsurprisingly, city lawyers love the restrictive system. Probably with tongue in cheek, Celeste Koeleveid, Law Department spokeswoman, wrote the court saying, "The city respectfully submits that the plan is an extremely worthwhile case management tool."

Several lawyers have questioned the Federal Judiciary Committee's authority to set up rules which favor the city so clearly that the Torts Department works hard to have the city "move" state Supreme Court cases into the Southern District on various pretexts.

In at least one case, a Manhattan attorney blamed the plan for needless discovery delays imperiling her case, which was soon to run afoul the Statute of Limitations. Unable to learn the identities of the NYPD officers who had allegedly knocked her client down and "falsely" arrested her, she was forced to settle the case quickly rather than risk losing her client's rights.

For whatever reasons, the federal committee is taking another look at its controversial plan, and last month held a forum to air myriad complaints from the plaintiffs civil rights bar.

Times writer Colin Moynihan wrote that the powers-that-be in the Southern District might come up with a new plan. Or not.

Racism Killed Trayvon, Racism Tainted Verdict

George Zimmerman should never have walked away a free man

from his trial for the murder of Trayvon Martin. From the ragged, noisy start, the "prosecution" was hamstrung from racial profiling by the arresting officers who bought Zimmerman's "stand your ground" story hook, line and sinker.

Many experienced attorneys believe Zimmerman was "over-charged," i.e. the prosecution, bowing to public pressure, indicted him on the highest possible count — *Murder Two*.

Sanford, Fla. Police — possibly caught in their "stand your ground" statute - waited six infuriating weeks to finally arrest Zimmerman.

Our media have such short memories that after the trial there has been very little reporting on the initial public outcry that just a year ago ultimately swept the nation and brought about the much-delayed indictment. The Murder Two charge was filed to deal with public uproar, not with a view toward a provable criminal case.

The prosecution's initial erroneous charge was never corrected until most of the Zimmerman trial was completed. Too late, the prosecutors woke up and the judge permitted them to add the Negligent Homicide "lesser included" charge.

It was a clumsy, ham-handed gesture. All along, it was evident the prosecutors had been trying to prove an unprovable case. Blaming the lawyers would be easy, but they are subject to all kinds of political pressures — local and statewide.

The elements of racism, irresponsible gun ownership and phony "law and order" behavior were there. Yet most knowledgeable attorneys, who focus on criminal law, assured us — in person, on television, on the web and in newspapers – that the prosecution would never be able to convince the jury "beyond a reasonable doubt" of Zimmerman's guilt on

the Murder Two charge.

Some TV talking heads, including a few lawyer, ignored the critical evidentiary difference between "preponderance of the credible evidence" (the civil burden) and "beyond reasonable doubt. "So, unfortunately, did the Florida prosecutors.

Zimmerman should never have been carrying a gun on his "watch." Too often, a gun-toting vigilante gets shot when confronting a "suspect," despite well-publicized admonitions highlighting the risk of doing so.

Zimmerman, whose physical battle talents were minimal, possibly recalled this warning too late, when the athletic and frightened Trayvon knocked him to the ground.

With the tougher youth on top, Zimmerman was likely aware that the concealed gun strapped behind him placed him in peril, should his stronger opponent detect its presence.


Even though he wore the gun in a back holster, it was within the grappling youth's likely reach. Zimmerman's paper-thin bravado would quickly collapse and he had to scream for help.

We'll probably never know exactly what happened, even though Zimmerman will one day produce a book telling the "true story" relating his version of that horrible night.

Trayvon Martin's parents have been extremely gracious following the verdict. Their behavior stands in stark contrast to juror B37, who made cruel derogatory remarks to CNN about Tranyon and the shaken female friend he was on his cell







Brooklynite's Noir Fiction Depicts A Gentrifying Clinton Hill



Set in Brooklyn in the early 1990s, Brooklyn writer Andrew Cotto's novel "Outerborough Blues" (Ig Publishing) brings the borough to life through mystery.

Taking place over just one week, the story centers on Caesar Stiles whose grandmother immigrated to New York from Sicily, settled in the Bronx, and had four children. Caesar's parents, who never legally married, moved to New Jersey and had three sons. When Caesar grew up he resolved to "find a home in the mysteries of Brooklyn."

Soon after his arrival, while working at a bar in his neighborhood, Caesar encounters a young, beautiful woman from the South of France. She tells Caesar that she is searching for her missing brother, and he agrees to assist her. But Caesar has his own demons - he is grappling with a troubling family past and struggling to feel comfortable as a white man living in a largely African American community.

Navigating the streets of a quickly changing Brooklyn on the brink of gentrification, Caesar attempts to solve the mystery and make sense of his family's convoluted history.



Cotto's first novel, "Domino Effect," is set in Queens, but for "Outerborough Blues", a noir fiction, the author looked to Brooklyn as a backdrop. "Gentrification is a huge part of this story," he told the Eagle in a recent interview. "I really wanted the book to reflect the very early stages of it, since the atmosphere is more raw, more dangerous, and exciting. There is something looming, though the inhabitants don't exactly know what to make of it, which creates fear...or opportuni-Cotto explained.

The author, now a Carroll Gardens resident, has

"As an author, I'm constantly informed by my surroundings," he told the Eagle. "My antenna is always up. I'm lucky - as a writer, at least - to have had an itinerant adolescence, moving frequently to diverse settings before settling in NYC in the early '90s."

Laura Prepon, best known for her role as Donna Pinciotti in "That '70s Show," felt intimidated by her role on the new Netflix series "Orange Is the New Black." But that turned out to be a good thing.

When I read it, it was so good but I was like, 'Wow, [the character] Alex scares me a little bit,' which is exactly why I needed to do it - and I'm so glad that I did," she said in a recent interview. "I feel like every actress is always looking to [push the envelope] because the minute you get complacent, hang it up."

'Orange Is the New Black" is the latest original series from Netflix, now available for viewers' binge-watching pleasure. The show is inspired by the story of Brooklynite Piper Kerman, who recently spoke to the Brooklyn Eagle about her memoir "Orange is the New Black," on which the TV series is based.

On screen, Kerman's character is a woman named Piper Chapman (played by Taylor Schilling), who fell in love with Prepon's character, Alex, in her early 20s, and was persuaded to be a drug mule for her. She only did it one time, but was named 10 years later by Alex as a part of a drug ring.

Prepon was a member of the cast of the long-running Fox sitcom "That '70s Show" that also starred Topher Grace, Ashton Kutcher, Danny Masterson, Mila Kunis and Wilmer Valderrama. They have all continued to work since the show went off the air in 2006.

"It's kind of rare that everybody on a cast moves on to awesome stuff. We're really fortunate and we all kind of keep each other in check. Like Danny (Masterson), I dated his brother for nine years. I'm like best friends with his mom, so Danny really is like my brother. It's a really tight group, it's great."



A Shared Struggle: Muslim and **Jewish Fasters Break it Together**

Brooklyn's Jewish and Muslim communities have used a common fasting day to build stronger bonds be-

tween them. Last Tuesday, July 16, Jews observed Tisha B'Av, the saddest day of the Hebrew calendar which commemorates the destruction of the First and Second Temples, and is a strict fast dav. Meanwhile, until Aug. Muslims are observing the holy month of Ramadan, during which they believe the prophet Mohammed received revelations from God, which are recorded in the Qu'ran. Both fasts end at sundown, and the timing inspired Congregation Beth Elohim in Park Slope, the Turkish Cultural Center and the Kings Bay YMHA to hold a joint breakthe-fast meal. Muslims call this meal the Iftar, and hospitality is a central part of this tradition.

The large Reform temple in Park Slope had already enjoyed an ongoing friendship with the Kings Bay Y and is starting a new relationship with the Turkish Cultural Center. Helping bring them together was the Peace Islands Institute, a non-profit organization that is experienced in this very work.

"Basically, we form dialogue groups and understanding between religious groups," Ibrahim Sayar told the Brooklyn Eagle during the Iftar. Mr. Sayar is the director of the Peace Island Institute's Center for Interfaith Affairs. They have worked with Congregation Beth Elohim in recent years.

"This kind of event is not new," Sayar explains. "We have different programs with different communities: different churches, different churches and temples—and even Buddhist groups, not only Jewish people." Working in seven U.S. states, including New York, Sayar knows from experience that "it really helps to bring people together, give them first-hand experience of the other. Because the information that we are receiving about the other culture is usually from second-hand or third-hand: through media or the books that we know. And the media can be sometimes deceiving.

Fasting is a shared practice, and is common to several religious traditions. "I think Ramadan is one of those occasions when we can share this kind of experience," said Sayar. "Particularly today, since the Jewish community and Muslim community are fasting at the same time. And breaking fast at the same table means a lot."

He added, "As people communicate [and] experience each other, they continue the relationship throughout the year.

Rabbi Marc Katz, Assistant Rabbi at Congregation Beth Elohim, points out that the Kings Bay Y and the Turkish Cultural Center both "have a wonderful glad that within their relationship that they've been building, they've brought our community in as well. From our previous years of engagement with the Kings Bay Y and our new engagement with the Turkish Cultural Center, we're so happy to be building these bridges, and especially to be forming these relationships."

Leonard Petlakh, executive director of the Kings Bay Y, said of Congregation Beth Elohim, "We couldn't think of a better place to bring these two communities—the Jewish community and the Muslim Turkish community - together in this special place. So my brother Suleyman [Aydogan] brought up the idea of having the Iftar dinner at a synagogue—and then he had a follow-up ideahe's absolutely responsible for the fact that we are here in this wonderful place of worship. It's beyond a place of worship: it's a cultural center, it's a real spiritual center for the community of Park Slope." Mr. Petlakh also saluted CBE's Senior Rabbi Andy Bachman, who was in Israel at the time of the event.

"I have witnessed firsthand the great work that the Turkish Cultural Center does all over the world," said Mr. Petlakh. We have traveled together to Turkey, Israel and other places. I've been amazed at the dedication and commitment that the people at the TCC bring into their work."

Zafer Akin, president of Peace Islands Institute, said, "The Turkish community and Jewish community—we have so much in common: Devotion to our families, our mosques, synagogues, dedication to peace. The idea behind tonight's both have our own values, our own culture, our own backgrounds, and yet we can still come together: not just in an atmosphere of friendship, but as a family."

Also present were Suleyman Aydogan, Director of TCC Brooklyn; Cindy Greenberg, CBE'S Program Director, who organized the event and managed details including the room décor; State Senator Eric Adams, and State Supreme Court Iustice Bruce Balter.

Why Compliance Experts Are the **New Key to Mega-Deals**

Last week, Hertz (HTZ) won final approval for its Dollar Thrifty deal from the Federal Trade Commission. China-based Shuanghui International Holdings is trying to gobble up Smithfield Foods (SFD), though the proposed deal is being examined by the U.S. Senate Agricultural Committee. The merger of Office Depot (ODP) and OfficeMax (OMX) was recently approved by shareholders. Involved in all these deals were highly skilled compliance and risk officers, often the "stop" and "go" lights for business.

In fact, having spent decades as a lawyer in Washington, D.C., I have observed first-hand business and government taking the speed of business to a screeching halt -often through regulations and compliance.

Conversely, I have watched new regulations serve as a launching pad for the proliferation of unimaginable growth and change of an industry.

Such was the case in telecommunications, where I was privileged to provide input to the Telecommunications Act of 1996. Though the act seems like folklore, it was the beginning of a deregulated environment that brought forth unprecedented change leading to the proliferation

tory change unlocked the telecom industry for sustained growth. Now the same is happening in energy and financial services.

For companies to grow, merge and prosper, complying with the rules and regulations in telecom, healthcare, real estate, online business, bank-

ing and investments, to name a few, has become a full-time job for many. For others, finding the combination to unlock a clear path through a regulatory environment is often critical to success.

Compliance requirements since the turn of the century have been game changing for business. Consider Sarbanes-Oxley and the requirements it imposed on all public companies, or Dodd-Frank and the continued regulatory pressure on the public markets and banking and lending institu-

tions. Now the Affordable Care Act requires teams of people and consultants to assure that states, health insurers and employers meet compliance

requirements and measure risk.

Change can be driven by the need for fair competition, as is the case for deregulation, or rules imposed when disaster strikes - such as the housing collapse or the Madoff scandal.

Regardless, if the last 10 years is any indication of what is to come, we are faced with a future that

> will have more competition and more innovation, but also more rules of the road and more risk, not less. And for business to forge ahead, compliance and risk management officers must figure out how to unlock growth and mitigate problems.

> The need to manage this regulated environment had led enterprise service companies such as Oracle (ORCL) and IBM (IBM) to offer new enterprise risk applications. While the demand for it indicates that technology is needed to keep up with the pace of the needs

for risk management, people are needed to make final decisions. Additionally, as companies activate new compliance software to meet regulations, compliance executives must work hand-inhand with information technology staff.

The need for highly qualified people has never been more apparent than the job listings we now are seeing for compliance officers. A phrase that is increasingly making its way into the lists of qualifications is this: "JD from an accredited law school preferred." And, according to a 2012 article in Fortune about compliance jobs at banks and hedge funds, "At America's Job Exchange, listings in the compliance space have exploded: There were 9,148 jobs with 'compliance' in their title for the second half of 2011, up from 221 a year ago, according to company president, Rathin

Further, the article noted. "... a law degree is critical for high-level positions. Leadership and good presence in the boardroom also help as compliance officers at investment banks and hedge funds work with top management."

Having spent the past year as the dean of a law school, totally focused on where the jobs will be for our graduates, I see a pattern emerging. Demand for risk and compliance professionals with is high — those with a JD degree are preferred. Yet, the supply is low.

But as we continue to see more regulations that need to be managed and adhered to globally - and as more companies are slowed by an inability to do so – compliance and risk managers are going to be paid handsomely. For companies, it will simply make business sense. In this new world, law and business compliance and risk assessment are keys that open and unlock deals. Lawyers are needed not to say "no," but to say "when and here is how."

Companies and financial institutions will do anything to assure that the traffic light of business says "all systems go."

treat all spouses the same when it comes to benefits, no matter where they live. DiNapoli notes some companies rely on federal law to define marriage when it comes to providing

DiNapoli's latest effort to leverage the pension fund to change the policies and practices of companies in which it is invested has drawn

"It seems very political," said Margaret O'Keefe, project manager for the fiscally conservative Manhattan Institute's Proxy Monitor database. "DiNapoli should be more focused on getting a better return on the pension fund and not focus on these social issues."

'We must have national recognition. DiNaptoli is fighting where he should be fighting. He is taking the initiative. Hats off to him. I applaud his efforts," Levine declared.

NY Official Pushes Feds To Recognize Gay Marriages

New York State Comptroller Thomas DiNapoli is using the power of the state's \$160 billion pension system to urge President Barack Obama to order federal agencies and programs around the country to recognize gay marriages performed in New York.

DiNapoli's idea is to adopt a "place of celebration" standard in federal government, meaning that gay marriages that take place in New York would be recognized even in states that do not per-

mit them. It could be a big push in DiNapoli's effort to get major companies that do business with the pension fund to adopt anti-discrimination measures when providing benefits for gay

As previously reported in the Brooklyn Daily Eagle, the U.S. Supreme Court

last month struck down parts of the federal Defense of Marriage Act, the federal law that prevented same-sex couples from receiving federal benefits akin to heterosexual couples.

"Bravo to the Supreme Court as our nation has taken another step towards a day when every lesbian, gay, bisexual and transgender American is treated with liberty and justice," Brooklyn Borough President Marty Markowitz said at the time of the ruling.

While monumental, the July decision by the U.S. Supreme Court left intact a provision of the federal anti-gay marriage law that allows a state to not recognize a same-sex marriage performed elsewhere. That means 37 states may not have to recognize gay marriages performed in New York.

That is now the critical battleground for us," said Marc Levine, president of the Gay/Straight Alliance of New York State Courts. "This is a replay of what happened with the fight to recognize interracial marriages where other states refused to. The very notion that a state would not recognize a marriage that was preformed in another state is bizarre. That is a conflict."

DiNapoli was scheduled to send his plea to President Obama in a letter to be released Friday.

"It's good for business," said Susan Sommer, director of Constitutional Litigation and Senior Counsel Lambda Legal, which defends gay rights. "It will remove any lingering argument some companies have been hiding behind ... and it reflects some very well established principles." Stephen

his request," Hayford said.

DiNapoli is the sole trustee of the state's pension fund and has used it as leverage to persuade companies he invests in to bolster environmental protections, combat terrorism and disclose campaign donations. He argues recognizing gay marriages is just good business.

"I have become increasingly concerned that companies that refuse to protect their employees from discrimination based on their sexual orientation or gender identity, and those that exclude same-sex spouses from employee benefit plans that are available to opposite-sex spouses, are hurting their financial bottom line," DiNapoli wrote in the letter to Obama.

DiNapoli said discrimination hurts a company's ability to recruit and retain top employees, and that could hurt the pension fund's investment in those companies.

Schneiderman Urges Congress To Restore Part Of Voting Rights Act

On Thursday, the U.S. House Judiciary Committee conducted a hearing focused on restoring the Section 5 preclearance provision of the Voting Rights Act following the Supreme Court's June 25 ruling in Shelby County, Alabama v. Holder. The hearing, which followed a similar hearing held before the Senate Judiciary Committee, marked an important first step in the effort to restore a core provision of this federal civil rights law.

Attorney General Eric T. Schneiderman has submitted a letter to the committee urging swift and careful congressional action to ensure the continuing vitality of the law.

"I urge the House Judiciary Committee to restore Section 5 of the Voting Rights Act, which has played a vital role in combating discrimination against voters for decades," said Schneiderman "As my office has argued in the Supreme Court, Section 5 has been a crucial tool for the protection of voting rights in areas covered by the law, including in parts of New York. I applaud Congress for taking this important step to ensure that the important protections provided by this law remain in place.'

A.G. Schneiderman led a coalition of covered states in filing a friend-of-the-court brief urging the U.S. Supreme Court to preserve the protections afforded by Section 5, which requires states and state subdivisions with a history of voting discrimination to obtain federal review of voting changes to ensure that those changes were not adopted with a discriminatory purpose, and will not negatively impact minority voter participation.
