# BROOKLYN TODAY Aug. 14

Good morning. Today is the 226th day of the year. The Brooklyn Daily Eagle for Aug. 14, 1902, carried the unusual story of a 17-year-old young lady, Mamie McFadden of East New York, who went on an excursion boat with fellow members of a lodge but failed to return that evening. The next day, it turned out that she had gone out to a restaurant with several members of the crew, gotten drunk, and had been kept in a room aboard ship overnight. Left unsaid but implied was the possibility that one of more of them had had sex with her.

Well-known people who were born today include journalist Russell Baker, actress Halle Berry, singer-songwriter David Crosby of Crosby, Stills, Nash & Young, singer-composer Buddy Greco, Hall of Fame basketball player Earvin "Magic" Johnson, cartoonist Gary Larson ("The Far Side") and comedian Steve Martin.

#### Bishop To Present \$20K to Program

# De Blasio Surges Ahead in Race for Mayor

Public Advocate Bill de Blasio, former councilman representing Park Slope and Carroll Gardens, leads the Democratic race for New York City mayor with 30 percent, according to a Quinnipiac University poll released Tuesday.

De Blasio is followed by former front-runner City Council Speaker Christine Quinn, who has dropped to 24 percent. Former Comptroller William Thompson, also a longtime Brooklynite, polled 22 percent.

The three top runners are followed by former U.S. Rep. Anthony Weiner with 10 percent, followed by 6 percent for Comptroller John Liu, 1 percent for former Councilman Sal Albanese and 7 percent undecided, the poll finds.

Quinnipiac attributed de Blasio's surge, with four weeks left in

the campaign, to "strong support from white Democratic likely primary voters" and "voters critical of the so- called stop-and-frisk police

De Blasio has impressed Brooklyn voters with his ambitious proposal to form a Brooklyn Health Authority, with sweeping powers to preserve healthcare and hospitals in Brooklyn. His plan for universal preschool has also been applauded, along with his focus on poverty in New York City.

Whether we are ahead in the polls or behind, Bill de Blasio's message has always been clear. He is the only Democrat who will break from the Bloomberg years by raising taxes on the wealthy to invest in universal pre-K and after-school programs, ending racial profiling, and fighting to save community hospitals," de Blasio's campaign manager, Bill Hyers, said in a statement on Tuesday.

Among those critical of stopand-frisk, 34 percent back de Blasio, with 24 percent for Thompson and 22 percent for Quinn. Democratic likely voters support 66 to 25 percent the creation of an inspector general to independently monitor the New York Police Department.

"A few weeks ago, Public Advocate Bill de Blasio looked like an also-ran. Today, he's the leader of the pack, and a winner in the runoffs. Follow the bouncing ball, folks. This line-up keeps changing," said Maurice Carroll, director of the Quinnipiac University Polling Institute.

'Nobody thinks former U.S. Rep. Anthony Weiner will pack it in, but 52 percent of likely Democratic primary voters wish he'd go away and 51 percent say they'd never vote for him," Carroll said.

# **West Nile Mosquitoes Spread Across Brooklyn**

#### **Use Repellent and Drain All** Standing Water, Officials Say

West Nile virus has been detected in infected mosquitoes in Brooklyn and is spreading rapidly, according to data provided by the New York City Department of Health (DOH).

On Aug. 9, the latest date for which information was reported, West Nile was detected in Dyker Heights, Broadway Junction, Gra-Georgetown, Farragut, Flatbush. Greenwood Heights and Canarsie (Zip codes in-

clude: 11203, 11207, 11214, 11228, 11232, 11234 and 11236).

While mosquitos carrying West Nile had been detected in Staten Island and Queens earlier this summer, they were discovered in Brooklyn for the first time on Aug. 2, in Dyker Heights.

While most people infected with West Nile suffer no long-term damage, about 20 percent come down with West Nile Fever or more severe "neuroinvasive" effects ranging from headache or neck stiffness to convulsions, inflammation of the brain or death.

Last year, 26 people across the city suffered from neuroinvasive effects, with six in Brooklyn. Of these, 23 percent (six people) died. Another 15 came down with West Nile Fe-

According to DOH, people in areas where the virus has been detected - especially those over 50 should take extra care to prevent mosquito bites. Parents of young children should also take care, as should people with compromised immune systems.

So far this year, two people, both from Staten Island, are known to have come down with severe cases of West Nile-related illnesses: encephalitis, meningitis or acute flaccid paralysis, which is severe muscle weakness associated with West Nile virus infection.

To trace the virus, mosquitoes are collected in special traps from over 90 pools citywide. While aerial spraying has been carried out in Queens and Staten Island throughout the summer, no spraying has been scheduled so far for Brooklyn.

DOH gives the following advice: Use repellents that contain DEET, Oil of Lemon Eucalyptus, IR3535, or Picaridin and always fol-

low label instructions. • If outside from dusk to dawn, wear protective clothing if possile, such as loose-fitting pants, long sleeved shirts and socks.

 Make sure that your doors and windows have tight-fitting screens. Fix or replace screens that have tears or holes.

• Reduce mosquito exposure around your home:

• Eliminate any standing water that collects on your property.

• Remind or help neighbors to eliminate standing water on their properties.

• Call 311 to report standing water.

# **Mayoral Candidates Weigh** In on Stop-and-Frisk

A federal judge's landmark decision on the Bloomberg Administration's controversial stop-and-frisk policing policy is shining a spotlight on the mayoral candidates at a time when the public is beginning to pay attention to the race for City Hall.

The candidates' reactions to Judge Shira Scheindlin's Aug. 12 ruling against the city in the class action lawsuit brought by residents who were subjected to stop-andfrisk by police ran along party lines, for the most part, with Democrats praising the decision and Republicans blasting it.

Of all the mayoral candidates, none was as succinct as Republican underdog George McDonald, who issued a two-sentence statement. "One misguided liberal judge is endangering the safety of all New Yorkers. Appeal, Appeal!" he said.

Republican Joe Lhota, who served as a deputy mayor in the Giuliani Administration, also urged Mayor Michael Bloomberg to appeal Scheindlin's decision.

"Our constitution is a living document, and I disagree with some of Judge Scheindlin's conclusions regarding the use of stop, question and frisk and the Fourth Amendment. I urge the mayor to appeal the decision to delay implementation of a federal monitor. The NYPD is one of the most closely scrutinized law enforcement agencies in the country, with oversight from New York City's five district attorneys, two U.S. attorneys, the New York State Attorney General and the City Council," Lhota said.

Democratic front-runner Christine Quinn, on the other hand, said the decision proved that she and her fellow City Council members were right to vote to install an inspector general to oversee the NYPD.

"Today's court ruling affirms what we have known for some time: Too many young men of color are being stopped in the streets of New York in an unconstitutional manner, and that must stop. At the height of this program, some 700,000 New Yorkers have been stopped, with the overwhelming number resulting in no arrest or seizing of contraband. That's why the city needs -and I passed -an inspector general for the NYPD," Quinn stated.

Former city comptroller Bill Thompson vowed that if he's elected mayor, he would work with the federal monitor to ensure that the police fight crime in a manner that is fair to the rights of New Yorkers. He praised the lawsuit's plaintiffs. "I want them — and all New Yorkers to know that I will protect our streets and protect the rights of our people. I will uphold the law and work with the federal monitor to make sure New Yorkers never have to choose between their constitutional rights and their safety," he said.

Former Brooklyn-Queens Congressman Anthony Weiner called for changes in the stop-and-frisk policy. "This decision sadly confirms what was profoundly obvious. When the police stop tens of thousands of citizens who have done nothing wrong — the overwhelming number being young men of color — basic civil rights are being violated," he said.

The policy of using stop-andfrisk as a deterrent rather than a tool for the pursuit of actual criminals has to change," Weiner added.

Public Advocate Bill de Blasio used the judge's decision to take a swipe at Quinn: "The courts have just affirmed facts that too many New Yorkers know to be true: Under the Bloomberg Administration, with the acquiescence of Speaker Quinn, millions of innocent New Yorkers — overwhelmingly young men of color — have been illegally stopped," he said.

The overuse and misuse of stop-and-frisk hasn't made New York a safer city. It has only served to drive police and community further apart," de Blasio added.

Comptroller John Liu is the only mayoral candidate who called for the outright abolition of stop-andfrisk. "The judge's call for reforms must be heeded, and — longer term — the tactic should be abolished. It's time to put an end to stop-andfrisk once and for all," he stated.

Republican John Catsimatidis expressed disappointment with the decision. "Stop-and-frisk is an example of proactive police work that stops crime and keeps guns off the streets; dropping crime rates have proven that. I am sure this decision will be appealed to the Second Circuit Court of Appeals, as it should be," he said.

"The New York City Police Department is the best in the world, their innovative crime fighting tactics are a model for law enforcement worldwide. Today's decision should not be viewed as an indictment of their tactics," he said.

Former Bay Ridge Councils Sal Albanese said the judge's decision proves that stop-and-frisk, while not a bad policy, was abused by police: "The courts upheld what any reasonable New Yorker has known since day one: Stop-andfrisk is a legal police tool that keeps our city safe when it is used properly. There was never any doubt that the city was casting too wide of a net and focusing on quantity rather than quality when numbers peaked in 2011. Since then, the NYPD has moved in the right direction by training officers better and reducing unnecessary stops," he said.

#### Social Security Bill Passed


President Roosevelt signed into law on August 14, 1935, one of the most important pieces of legislation in American history — the Social Secu-

It would provide a pension to Americans over the age of 65 (beginning in 1942), paid for by contributions from employee wages and matched by employers, It also would give assistance to the blind and disabled and to dependent children. At the same time, it established a system of unemployment compensation.

Glowing with pride because the act fulfilled a campaign promise. the President called the legislation the "cornerstone" of the New Deal and a "supreme achievement."

It would differ from welfare in that it would not be funded by taxes.

However, liberal critics of the plan said the poor would pay an inordinate amount of the

burden. Conservative critics said it was yet another measure pushed by the President to "Sovietize America." Some business owners were riled by the act because it cut into their

But a majority of Americans hailed it as a program that was long overdue; other Western industrial nations had had a system to care for the elderly

#### Hero of Two Worlds Honored

companied by his son Georges Washington Lafayette, his secretary and his valet, the Marquis de Lafayette arrived off Staten Island on August 14, 1824 for what promised to be a triumphant year-long tour as the guest of the nation. While artillery from shore batteries and warships moored in the harbor thundered salvos in his honor, Vice President Tompkins, the city's leading citizens and many old comrades-inarms boarded the packed ship to greet the 67-year-old marquis. Hundreds of boats decked with colorful flags and pennants surrounded the ship while crowds lined the shore



to welcome "home" the man they called the "hero of two worlds."

On April 10, 1825 the Marquis' tour reached New Orleans where he was greeted by cheering crowds, ringing bells, parades, speeches, balls and reunions. The marquis was showered with gifts, and great care taken to see that he was put to no expense, for it was well known that the marquis impoverished himself while helping America win its freedom. Congress had made substantial, if belated, amends in January by voting him the sum of \$200,000 and a Florida township of 24,000 acres.

# The Navy Yard Blues

the last fighting ship to be built at the Brooklyn Navy Yard, was launched there on August 14, 1965. Mrs. Bruce Solomonson, a daughter of Vice President Hubert H. Humphrey, christened the ship. Senator Robert F. Kennedy and representatives from the New York City congressional delegation were invited to the ceremony but avoided it to escape the anger of naval yard workmen who had lost their jobs and felt betrayed by the U.S. Government.

The Duluth was an amphibious transport dock (LPD) which is one of the most versatile classes of ships in the Navy. The LPD combines the functions of three different classes of ships: the landing ship (LSD), the tank landing ship (LST), and the attack cargo ship (LKA). The vessel was named after the city of Duluth, Minnesota.

Work began in December 1963, the keel being on the 18th. The craft is 569 feet long, with a beam of 100 feet. Her displacement is approximately 16,710 tons, and she has a sustained speed capability of twenty knots. Due to her design, Duluth maneuvers as easily as a destroyer.

Duluth is unique in having a helicopter platform built over a well deck in the rear of the vessel. This provides the tactical advantage of being able to lift troops, their combat equipment and supplies onto the same ship. Therefore the ship contributes to all phases of the amphibious assault. The well decks are upper and lower vehicle storage areas, which hold most of the embarked troops' heavy combat equipment such as tanks, tracked amphibious landing vehicles (AAV), jeeps and trucks. To facilitate the docking and loading of various sized landing craft, the ship can ballast down in the water, thereby flooding

the well deck with enough water to enable the landing craft to enter the well deck through the stern gate door. Once locked inside the well dock, troops, supplies and combat equipment can be loaded into or off of the amphibious boats and vehicles while simultaneously transporting troops and equipment via helicopter from the flight deck.

During its long and colorful career, Duluth has made many deployments to the Western Pacific.

The Duluth has visited many exotic and exciting ports from Aukland, New Zealand, to Vancouver, British Columbia; from Mazatlan, Mexico, to Mombasa, Kenya.

The ship has also been involved in numerous exercises and operations.

In early September 1983, while visiting Mombasa, Kenya, Duluth was unexpectedly ordered to waters off the coast of Beirut, Lebanon, to support the multi-national peacekeeping force

ashore.
While sailing to the Mediterranean, Duluth was part of the First Amphibious Ready Group from the west coast to transit the Suez Canal.

As a result of its participation in the peacekeeping operations, *Duluth* was awarded the Navy Expeditionary Medal and Meritorious Unit Commen-

In July, 1984, Duluth made a port call to Juneau, Alaska, to share in that city's Fourth of July celebration and to commemorate Alaska's 25th anniversary of statehood.


Among its many more recent duties it was one of six ships that provided watch relief, harbor security, damage control equipment, billeting, and food service for the USS Cole following the explosion that damaged that ship on October 12, 2000, off Aden, Yemen, with the loss of 17 Navy men's lives.

# Fixing America's Subsidized Homeownership

Measuring people's happiness is now popular among many economists. Even Federal Reserve Chairman Ben Bernanke said recently the world needs better ways to determine "economic well-being" than aggregate data like housing starts. That's good advice for President Obama and Congress as they move to fix a broken piece of the American dream – its housing system – with new legislation.

Government support for homeownership in the United States has not only proved costly – a housing bubble, then a market crash, the Great Recession, and now a weak recovery – but it has hardly brought personal well-being.

Countries such as France, Germany, and Switzerland have rates of homeownership that are well below those in the U.S. Yet a survey known as the Better Life Index shows people in those European countries are more satisfied with their housing situation.

Mr. Bernanke also notes that a person's wealth, such as equity in a house, does not contribute to self-reported happiness. Costa Ricans are as happy as Americans but one-quarter as wealthy. Rather, belonging to a group and feeling in control creates "life satisfaction." Economists focus too much on "material determinants," he says, rather than less measurable aspects, such as individual freedom.

Mr. Bernanke's comments are worth remembering as Mr. Obama and Congress try to craft new ways to subsidize homeownership and to protect taxpayers from another fiscal disaster like the government takeover of mortgage giants Fannie Mae and Freddie Mac.

The president wants private lenders to take on more of the risk of issuing mortgages, but not so far as to jeopardize the popularity of a 30-year mortgage at favorable rates. For that, however, Congress will still need to guarantee new mortgages with a government entity. A powerful lobby of home builders, bankers and real estate agents will likely drive Congress to approve such a step and once again put taxpayers at risk.

But lawmakers should at least step back and discuss a subsidy of the American dream in terms that economists like Bernanke and many others are now talking about: Does owning a house increase well-being?


Canada has a higher rate of homeownership than the U.S., but it achieved that without most of the subsidies that Americans enjoy. And Canadians are more satisfied with their housing situation. Canada also didn't suffer the 2007-09 market crash in home prices.

Other points that Congress can consider: By encouraging homeownership, government reduces the ability or willingness of laid-off workers to relocate to new jobs. Subsidizing homeownership has mainly benefited wealthy and middle-class Americans, perhaps worsening income disparities. And the nation as a whole might be better off if individuals put more than their money into better investments as export industries.


Fortunately, Obama backs proposals to increase the ease of renting in the U.S. With the mirage that "housing prices will always go high" now gone, the notion that paying rent is "throwing money away" has far less hold on Americans. At the least, government may now let a free market decide between buying and renting, rather than tip the scales with mortgage subsidies and guarantees.

If, as the Federal Reserve chief says, a person's satisfaction is better measured by individual freedom and being in control of one's life, then perhaps government needs to let the housing industry loose of its dependency on Washington. Happiness can be found by other means.

# 'Save Yourself' Depicts Suspenseful, Small-Town Story Author to Read in Park Slope

Kelly Braffet made a name for herself in the literary world with her first two novels, "Josie and Jack" and "Last Seen Leaving", both of which earned critical raves. Her latest book, "Save Yourself" (Crown Publishing), was just released on August 6 and already has garnered similar praise. Renowned Brooklyn writer Emma Straub ("Laura Lamont's Life in Pictures") offers the following assessment of Braffet's new novel: "Astonishing. 'Save Yourself' goes deep into the hidden and shameful parts of grief, love, and anger, and the reader emerges shaken and grateful on the far end." Braffet will appear in Brooklyn at Park Slope's Community Bookstore on Aug. 15 for a reading, book signing, and Q&A with Community Bookstore co-owner Ezra Goldstein.

"Save Yourself" engages the reader in a suspenseful story, as Braffet craftily alternates the perspective between two characters, Patrick Cusimano and Verna Elshere. Patrick works at an unpromising job in a convenience store, still residing in his childhood home with his brother, Mike, and Mike's girlfriend, Caro. His father is in jail; after discovering evidence that his father had drunkenly killed a six-year-old boy, Patrick turned his father in. Patrick's life since the incident has become increasingly bleak. His brother blames him for breaking up their family, and Patrick believes he might be in love with Caro, which only adds tension to an already dysfunctional family.

Verna, the other central character, has just begun high school and is also grappling with a crippling family dynamic. Her father is known for being an outspoken minister, which makes Verna the victim of harsh teasing at school. Her older sister, Layla, has a reputation for being an opinionated goth outcast. When Layla and her crew take Verna under their wing, Verna finally feels relieved and secure, but she comes to find that her sister's world is much darker than she had imagined. When Layla befriends Patrick, the characters' worlds collide.

Through dark and hauntingly realistic moments, Braffet reveals

a web of characters struggling to find themselves in a world rife with pain and rejection.

In anticipation of Braffet's upcoming reading at Community Bookstore, *Brooklyn Eagle* spoke to the author about the origins of this book and her longtime interest in horror stories.

#### How did the idea for this story originate?

This book came from two different roads that converged. The first was, to put it simply, desperation: I promised an old friend a short story for an anthology. I kept waiting for an idea to pop up, but eventually the deadline came close enough that I had to lock myself in

my office for a weekend and just write until I came up with something, and what I came up with was the Cusimano family. The anthology never happened – or at least, not with me in it – but the characters from the story stuck with me.

The second road was a book group discussion that I was lucky enough to sit in on after my second novel, "Last Seen Leaving", came out. One of the readers this was in western Pennsylvania, where my parents live - commented that she was bothered by the characters' lack of faith, and it struck me that it had never occurred to me to give any of my characters a religious life. So at the same time I was writing the story about the Cusimanos, I was also nursing this very vague idea about these two sisters raised by Christian fundamentalists, who ended up being Layla and Verna Elshere. Eventually it occurred to me to see what happened when I combined them: the family with no faith in anything meets the family ruled by faith.

## You develop such intricate characters - were some easier to create than others?

Always! Some characters just seem to sort of show up fully formed, and others take some coercing. Verna Elshere, for instance, probably has one of the toughest roads to travel in "Save Yourself." She's terribly naïve about the world outside her father's church, but – at the risk of sounding like a self-help seminar – I really wanted her to find her anger and her strength through the course of the book. Making sure that change was gradual and believable required constant attention.

Caro Haller, on the other hand, is one of those who just showed up, dressed and ready to play. I feel like I could write about Caro for years. For all I know, I might.

Have you always had an interest in dark, haunting stories?

As long as I can remember. My favorite version of Cinderella was always the one where the stepsisters cut off pieces of their feet so they could fit into the glass slipper.

What are you working on now?

"Save Yourself" just came out a week ago, so most of my time has been taken up with promotion: social media, blog postings, setting up events, and so forth. Which is all a lot of fun, but I'm looking forward to getting back to my regular writing schedule. I'm kicking around a few ideas for the next novel, but time will tell which one will stick to my foot.


mez's "Come & Get It," One Direction's "Best Song Ever" and "I Need Your Love" by Calvin Harris and Ellie Goulding.



# Pierce Adjusting to Life in Brooklyn

## Looking Forward To Helping New-look Nets Capture Title

After 15 seasons in Boston, 10 All-Star Game appearances as a Celtic, two NBA Finals berths and an historic championship run in 2008, it would be hard to blame Paul Pierce for having a touch of homesickness as he embarks on this new phase of his Hall of Fame-bound career in Brooklyn.

After all, Pierce will eventually have his No. 34 hung from the rafters at Boston's TD Garden, where he captured NBA Finals MVP honors while helping the Celtics grab their record 17th title, and came within a single victory of repeating the feat in 2010.

So it wasn't the least bit surprising to see Pierce appear slightly less than thrilled on the dais last month at Barclays Center when the Nets introduced him, Kevin Garnett and Jason Terry as the three newest members of our borough's first major pro sports franchise since the Dodgers left for Los Angeles in 1957.

"It's really starting to sink in as we speak," a noticeably subdued Pierce intimated back in mid-July. "I'm no longer a Boston Celtic. I'm a Brooklyn Net."

Last Thursday afternoon, during a meet-and-greet with local fans to promote Sprint's 4G LTE launch in Brooklyn and the Bronx, Pierce finally appeared ready to fully embrace his new role as one of the driving forces behind the Nets' heated pursuit of Title I on the corners of Atlantic and Flatbush avenues.

The player dubbed "The Truth" by Shaquille O'Neal for his willingness to answer the call under the most stressful on-the-court situations is looking forward to helping Deron Williams, Joe Johnson and Brook Lopez learn what it's like to hoist the Larry O'Brien Trophy come next season.

"I'm looking forward to getting started in September, getting acclimated to the new surround-

Those high-priced, well-decorated "pieces," which also include Garnett, Terry, Andrei Kirilenko, Reggie Evans and Andray Blatche, are currently being hailed as the "next big thing" in the race for the Eastern Conference crown.

But with Pierce leading the way, both with his scoring touch and battle-tested basketball acumen, the Nets now boast one of the sport's top go-to shooters in the clutch.

One of only three Celtics ever to amass 20,000 points in a Boston uniform (Larry Bird and John Havlicek being the other two), Pierce is eager to start attacking some of the Nets' single-season records during his Downtown relocation.

"It's a new building, new owners, and a new attitude," Pierce said after playing several rounds of S-P-R-I-N-T (aka H-O-R-S-E) with Nets fans at Basketball City. "The pieces are there in the locker room. I want to be part of starting a legacy."

Despite his admitted struggles with saying goodbye to his basketball home in Boston, Pierce has already played an instrumental role in helping the Nets form their version of "The Dream teammate Kevin Garnett to wave his no-trade clause and come to Brooklyn, along with Terry, forming a solid core group of experienced, championship-caliber players for rookie coach Jason Kidd to have at his disposal.

"I called Kevin and asked him what he thought about coming to Brooklyn, he immediately said, 'Well, what pieces are they going to give up? Who is going to be left? Is it going to be possible for us to win a championship?" Pierce revealed. "He was excited when I talked to him after warmbe grabbing the Atlantic Division title, something the Nets fell just shy of last season as the Knicks held on to the top spot and the accompanying No. 2 seed in the East playoffs.

Pierce, Garnett and Terry were eliminated by New York in the opening round of the postseason last year, and their well-documented rivalry with the Knicks as members of the Celtics figures to carry over, and perhaps even be magnified, during their stay in

"[Knicks-Nets] will be the best rivalry in sports this year," Pierce insisted Thursday, pointing to the teams' four regular-season dates and a potential postseason showdown as calendar-marking

If there was any doubt regarding Pierce's commitment to his new team, and new locale, one need only listen to what his goals are for next offseason.

"Come June or July, I want to be on beach somewhere looking back on a great year and a championship season," he said.

# Colton Leads Protest Against Gravesend Trash Plant

First Sandy, now the Sanitation Department is hurting us!

That was the cry from residents of southwest Brooklyn who took part in a protest rally Sunday against the city's plans to move ahead with the construction of a trash plant on the Gravesend waterfront.

Protesters charged that they suffered a great deal during Superstorm Sandy last October and that a trash plant will inflict more pain on them.

Led by Assemblyman Bill (D-Gravesend-Ben-Colton sonhurst) and local political leaders, dozens of residents took part in a protest demonstration against plans by the Dept. of Sanitation to construct a trash plant, called a marine transfer station, on the Gravesend Bay waterfront at Shore Parkway and Bay 41st Street. The new station would be built on the former site of the Southwest Brooklyn Garbage Incinerator, which operated for nearly 40 years until it was closed during the Giuliani Administration.

The rally took place outside the Caesar's Bay shopping mall, located on the waterfront on Shore and Bay parkways, a short distance from the proposed trash plant site.

Under the city's plan, garbage would be trucked to the marine transfer station. The trash would then be compacted at the plant and placed on barges for shipment to out of state landfills.

"The people of southern Brooklyn have suffered enough from the impact of Hurricane Sandy. We do not need a garbage station built and operated in our community to only further hinder our quality of life and hurt our families," said Mark Treyger, one of the rally's organizers. Treyger is a Democratic candidate for City Council in the 47th Council District (Coney Island-Gravesend-parts of Bensonhurst).

Opponents of the trash plant charged that the facility would increase truck traffic on their streets. The truck traffic would lead to increased incidents of asthma, caused by the truck fumes, residents said. The constant pounding of the trucks on the roadways would mean more wear and tear of local streets, protesters said.

Colton, who filed a lawsuit last year to try to stop the plant, said there are also environmental hazards. Gravesend Bay would have to be dredged to make room for the barges that would transport the trash out of the plant, he said. The dredging process will bring toxins in the bay to the surface, Colton charged.

"The former southwest Brooklyn incinerator, which was located and illegally operated for over 30 years by the city, spewed toxic ash containing dangerous chemicals into the waters of Gravesend Bay. If this garbage station is built, those toxic substances will be released into the waters across southern Brooklyn. We simply cannot allow the city to go forward with this plan," Colton said.

Toxic chemicals such as mercury, lead, and arsenic that are buried at the bottom of Gravesend Bay after being spewed into these waters by the former southwest Brooklyn incinerator, Colton and other protesters charged.

Residents also noted that the plant is located in an evacuation zone and that if there another large coastal storm like Superstorm Sandy that causes large amounts of flooding from storm surges, the toxic chemicals at the bottom of Gravesend Bay will end up in homes, schools, nursing homes and other public spaces.

The rally was organized by Sandy Task Force Recovery Organized by Neighborhood Groups, or STRONG, which was founded in January by Treyger and civic activists Priscilla Consolo and David Portalatin.

Leaders of STRONG have formed a new coalition called Dump the Dump and are seeking to galvanize opposition to the trash plant in Bensonhurst, Gravesend, and other communities in Brooklyn including Coney Island, Sheepshead Bay, Brighton Beach, Manhattan Beach, Mill Basin, Dyker Heights, Bath Beach, Bergen Beach and Bay Ridge.

# Documents Show Secret Service Kept Tabs on Swartz

# Accused Hacker Committed Suicide in Brooklyn in January Associated Press

Documents show that the U.S. Secret Service played a role in the federal investigation of free-information activist Aaron Swartz and watched his case until he committed suicide.

Swartz died in Brooklyn in January as he faced trial on charges he hacked into a Massachusetts Institute of Technology archive of scholarly articles with the aim of making

them freely available.

The Secret Service doc-

uments, released under the Freedom of Information Act, show the agency's Boston field office secured documents and electronic devices seized during a search of Swartz's home and research office at Harvard University.

Agents also joined local police who interviewed Swartz's associates, including a San Francisco woman who told them that he called her after he was arrested and asked her to call his lawyer to arrange bail.



# **Superstorm Sandy Scammer Stole Tens of Thousands**

#### 'Benefits' Included Free Stays at Brooklyn Hotel

New York state Attorney General Eric T. Schneiderman announced on Tuesday the arrest of Caterina M. Curatolo, who allegedly obtained more than \$87,000 in benefits by falsely claiming to have been a victim of Superstorm

An extensive investigation by the Attorney General's Auto Insurance Fraud Unit ("AIFU") revealed that Curatolo engaged in an elaborate scheme to defraud city and federal relief agencies, a private insurance company and charitable organizations by representing herself as a Sandy evacuee.

After Hurricane Sandy descended upon New York City and surrounding areas on Oct. 29, 2012, causing enormous damage and displacing thousands of New York City residents, the city contracted with hotels to provide interim housing for those evacuees by creating the New York City Hotel and Interim

Placement Program ("Hotel Program") At the same time, the New York City Mayor's Office established the Mayor's Office of Housing Recovery Operations ("HRO") to help administer housing accommodations to Sandy evacuees. All who were placed in the hotel program were assigned case managers and given housing, medical and financial resources.

According to the Attorney General's felony complaint, filed in Queens County Criminal Court, Curatolo falsely represented herself as a Sandy evacuee in order to obtain free hotel rooms and other benefits.

She was provided with free accommodations at three hotels in Queens and Brooklyn. Between Nov. 17, 2012 and Dec. 20, 2012, she was placed in the Quality Inn at 30-03 40th Ave., Long Island City, Queens. Between Dec. 1, 2012 and Feb. 21, 2013, she was placed in the LaGuardia Plaza Hotel at 104-04 Ditmars Blvd., East Elmhurst, Queens. Beginning on Feb. 20, 2013, Ms. Curatolo was placed in the Holiday Inn Express located at 625 Union St., Brooklyn, where she was still residing at the time of her arrest by AIFU investigators.

All in all, according to the Attorney General's Office, Curatolo was provided housing as a Sandy evacuee for more than 269 days at a cost of approximately \$83,500.

In addition to free lodging, based on her representations as a Sandy evacuee, Curatolo was given given a total of \$3,590 to spend on food. Instead, she spent some of the money at Best Buy, Dressbarn, Marshalls, Fabco Shoes, Eric Shoes, Optical Boutique and Exclusive Eyes, according to the indictment.

A crew of con men sold worthless penny stocks to people around the globe at pumped-up prices, then victimized the investors again by setting up a fake law firm that charged them to try to get their money back, federal authorities in Brooklyn said Tuesday.

The international scheme generated more than \$140 million, making it one of the largest penny stock fraud schemes in history, U.S. Attorney Loretta Lynch said at a news conference announcing an indictment charging nine defendants.

FBI agents arrested six of the defendants Tuesday in New York, Arizona, New Jersey, Florida and California. A seventh was being held in Canada and two were at large.

The indictment alleges that the defendants engaged in a massive "pump and dump" scheme — buying controlling interests in sketchy startup companies, then artificially inflating their value by promoting them in fictitious emails, social media messages and news releases. The fraudulent sales campaign generated more than \$120 million in investments by tens of thousands of people in the United States and 34 other countries, including Jamaica, South Africa, Ireland and China, authorities said.

## 'Lights and Sirens' Not Required For Traffic Stop, Says Brooklyn Judge

Stopping in front of a vehicle is not an aggressive police stop, Brooklyn Supreme Court Acting Justice Joel Goldberg ruled.

Police officers reportedly observed a Nissan Altima with excessively tinted windows fail to complete a stop at a stop sign. At the same time, police received an anonymous 911 call stating that a man in the same Altima had a gun.

In an attempt to ascertain whether or not a gun was in the car, as well as to cite the driver for traffic violations, police officers cut in front of the car to prevent it from going any further. Once they pulled the car over, police saw an occupant fumbling to hide a gun.

Queens defense attorneys Robert DiDio and Danielle Muscatello attempted to suppress evidence of the recovered gun, arguing that the police were unwarranted in the aggressive manner by which they stopped the defendant's car. They also argued that the aggressive stop startled the defendant, which is what allowed the police to discover the weapon.

The average motorist, the defense argued, would expect police officers to provide warnings to a driver that he or she is being pulled over—warnings including the use of lights, sirens or an announcement to

Goldberg agreed that the "use by the police of lights, sirens, and loudspeakers are all common methods of causing a motorist to pull over." However, he said, "there appears to be no legal prohibition on the police, who otherwise have a right to stop a motor vehicle, effecting that stop by cutting off the motorist," Goldberg contin-

The defense, Goldberg determined, did not provide sufficient case law showing limitations on traffic stop procedure. "Once the police have a right to stop a motorist, as they did in this case [due to the tinted windows and failure to stop at a stop sign],"

Goldberg ruled, "there is no requirement that the police first attempt to do so by escalating methods, beginning first with lights and then sirens and then loudspeakers, and only after these methods fail may the motorist be cut off."

Further, Goldberg ruled, the discovery of the gun was not the result of "spontaneous reaction" to being cut off by the "Having been stopped, whether over aggressively or not, it was the defendant's own actions in attempting to conceal the gun that permitted the police to observe it," wrote Goldberg.

The discovery would have been the same, Goldberg concluded, "if the defendant had instead voluntarily pulled over in response to police lights, sirens, and/or loudspeakers.

Kings County Assistant District Attorney Samuel DePaola represented the prosecution.
