Good morning. Today is the 233rd day of the year. On this day in 1897, the Brooklyn Daily Eagle carried an article with the headline "Officers Move Against Pool Rooms." By "pool rooms" they meant not billiard parlors, but places where people made bets on horse races. While waiting for the results from the track to come in by telegraph or telephone, they played billiards, and eventually the original meaning of the word was lost. The particular pool rooms in question were not in Brooklyn, but in Maspeth and Ridgewood, Queens. Some of them were in well-known athletic clubs, restaurants and political clubs, creating an embarrassing situation for police.

#### **B'klyn Att'y Guilty** Of Condo Fraud

A real estate lawyer has pleaded guilty to securities fraud, admitting he forged condominium plan acceptance letters from state authorities to enable developers to sell apartments without proper regulatory oversight.

The attorney general's office said Tuesday that 36-year-old Eduard Fridman of Brooklyn forged six letters from 2010 to 2012 and filed three with the New York City Department of Finance.

Under a plea agreement, Fridman will pay \$100,000, be on probation for five years and won't work in New York's securities or condominium businesses.

Sentencing is scheduled for Oct 7.



# Will Hakeem Jeffries Respect His Constituents On the Minimum Wage?

If the 1968 federal minimum wage grew with inflation, it would be \$10.67 today. If it grew with worker productivity, it would be \$22 today. If it grew with the incomes of the wealthiest one percent of Americans, it would be \$33 today. But where does it stand 45 years later? A miserly \$7.25. While Forbes' top 100 CEOs rake in more in an hour of work than the average low-wage worker does in a year, it is unacceptable for Congress to allow 30 million Americans to make less today than low-wage workers did 45 years ago in 1968.

Fortunately, there is a bill in Congress to rectify this injustice. Congressman Alan Grayson (FL) has introduced H.R. 1346, the "Catching Up to 1968 Act of 2013," which would raise the minimum wage to \$10.50 per hour and index it to inflation. Neither President Obama's nor Rep. George Miller's and Senator Harkin's minimum wage proposals come close to catching up with 1968 by 2016; only Rep. Alan Grayson's bill H.R. 1346 requires \$10.50 per hour, 60 days after passage. This necessary increase would be a major, immediate economic stimulus and expand employment.

Recently, over 300 citizens who live in the 8th district of New York signed a petition that I submitted, summoning Rep. Hakeem Jeffries to hold a town hall meeting to discuss H.R. 1346. Currently 34% of residents in East New York live under the poverty level. Rep. Jeffries is paid to meet with concerned citizens during the August recess, and he did not initially respond.


On Aug. 17, I went to his "outdoor office hours" in Coney Island to discuss in person. Mr. Jeffries has not yet responded to a specific meeting about the minimum wage. 70% of Americans and 50% of Republicans support a raise. Without a higher minimum wage and indexing it to inflation, it becomes more likely that low-wage workers will fall further into poverty and be more reliant on government services like food stamps, Medicaid, welfare and the earned income tax credit.

Despite pegging their own wages to inflation, Congress has failed to index the minimum wage to cost of living increases. As a result, low-wage workers have lost \$15.3 billion in wages since the minimum wage's peak in 1968. For every day that Congress fails to raise the minimum wage back to 1968 levels and index it to inflation, each minimum wage worker loses another \$26 in potential earnings. In the time between when his constituents first contacted him and now, minimum wage workers in Rep. Jeffries' district lost over \$1.3 million in potential wages. He currently supports a higher minimum wage, but has not yet co-sponsored H.R. 1346.

Even if Rep. Jeffries does not support this bill, we hope he can at least respect his constituents by holding the town meeting to which his constituents summoned him.



# **Judge Orders SUNY: Give LICH Back to Continuum**

#### Nurse Cites Support From Eagle, Others

Shock, amazement, relief and confusion greeted the blockbuster announcement on Tuesday that Brooklyn Supreme Court Justice Carolyn Demarest has ruled that SUNY Downstate must give back Long Island College Hospital (LICH) to Continuum Health Partners, or to another trustee if Continuum isn't able or willing to take it back. (See additional story, page 12.)

SUNY Downstate, which took over LICH two years ago under an arrangement signed off on by Justice Demarest, has been trying to shut it down since February. Residents, hospital staff and unions, Public Advocate Bill de Blasio and a a number of civic groups have battled in the courts and in countless rallies and marches to block what they called SUNY's plan to sell off LICH's valuable assets, said to be worth a half a billion dollars.

For many, Justice Demarest's order was a bolt out of the blue, since the bulk of the legal battles have been fought over the last few months in Supreme Justice Johnny L. Baynes' courtroom. Justice Baynes, after a remarkable three-day hearing two weeks ago, ordered SUNY Downstate to keep LICH partially open until an agreement could be reached about its operation, possibly under another operator.

In late June, however, Justice Demarest, after reading about "the demise of Long Island College Hospital (LICH) at the hands of the State University of New York (SUNY Downstate)" became "increasing concerned as to the propriety of my own order granting approval of the transfer of LICH's assets to SUNY Downstate in light of Downstate's apparent lack of stewardship over those assets in advancement of LICH's charitable purpose." Justice Demarest ordered SUNY Downstate to present a full accounting by August 5 of all LICH property, assets and funds transferred to Downstate.


Based on that accounting, and after a visit to LICH she made personally where she saw the hospital refuse to treat people in need of medical care, Justice Demarest determined "that I have a legal and moral responsibility to correct my earlier error."

"This win belongs to LICH RNs, staff, doctors, neighbors and community associates, Councilmen Levin and Lander, Senator Sqaudron, Assemblywoman Millman, the Red Hook Star and the Brooklyn Eagle," said Julie Semente, critical-care nurse at LICH and a member of the New York State Nurses Association. "Our relentless actions from January to June fighting the injustice that SUNY was perpetrating on LICH, and the superb, accurate reporting of these two local newspapers keeping SUNY's LICH scandal in the news everyday, caught Judge Demarest's attention and caused her to revisit her 2011 decision."

Semante also expressed gratitude to the court system. "As jaded New Yorkers who have witnessed the power of well-connected Albany insiders, especially in the past eight months, and we did not expect there could be justice for LICH. We are extremely pleasantly surprised and there is celebration at LICH today, with much gratitude and admiration for Judge Demarest, and appreciation for her integrity. The nurses, doctors, and staff at LICH, along with our neighbors, community associates and local elected officials fought so hard for so long because what SUNY was doing to LICH was wrong. As Judge Demarest has just shown, the truth matters."

"This order validates our suspicion that SUNY took over LICH with the intention of profiting off of the real estate – valued at up to \$1 billion," said Jill Furillo, executive director of the New York State Nurses Association. "Real estate profits must not be put before the healthcare needs of an entire community. We hope that this order will take us one step closer to our goal of keeping LICH open for care and letting profiteers know that we will not let them close any our hospitals — not LICH, not Interfaith, not any New York hospital."

A spokesperson for Public Ad-

vocate Bill de Blasio, who has been deeply involved in the fight to keep LICH and other threatened hospitals in Brooklyn open, did not want to comment until he had read the court decision.

In her scathing eight-page decision and order, Justice Demarest wrote that the original rationale behind the transfer of LICH to SUNY Downstate two years ago "was the representation that LICH would be preserved as a hospital serving the people of Brooklyn."

Justice Demarest continued, "Recent events have established that the consideration, which the Court found to be fair and reasonable in the circumstances, has failed, possibly by design, and that this Court, and many of the other interested parties, may have been deliberately misled at the time the transfer was approved."

#### 'In Clear Violation'

Closing LICH is in "clear violation of [SUNY's] commitment," she wrote. Justice Demarest also said that had she known about SUNY Downstate's dire financial condition at the time it took over LICH, "the petition would not have been granted."

The order also says that SUNY may have misrepresented the amount of losses they've sustained related to LICH operations, and that at the time SUNY took over LICH assets they claimed that they were prepared to sustain these losses and still keep the hospital operational. "SUNY Downstate's actual losses attributable to LICH approximate \$30 million at this time," she wrote. "Moreover, LICH's Liability Fund is actually in very good financial condition, to the extent that SUNY has sought to cover its own financial difficulties by accessing LICH's retained assets."

SUNY Downstate spokesperson Robert Bellafiore did not say whether SUNY would contest the order. "Today's court order directs ownership and operation of Long Island College Hospital back to Continuum Health Partners. SUNY has made clear it is exiting LICH so it can stabilize Downstate and today's judgment is another move in that direction," he said in a statement.

"The facts are that when SUNY acquired Long Island College Hospital it was done with the best of intentions; save a hospital that was on the verge of closure, grow the struggling Downstate enterprise

as a strategy to survive, and provide additional clinical training opportunities for our students. SUNY has poured millions of dollars into LICH in an attempt to reverse nearly two decades of financial losses. Unfortunately, SUNY and LICH became victims of the daunting realities of Brooklyn's health care delivery landscape. We are disappointed it did not work, but it was not for lack of effort," he said.

He added, "It is unfair to ask our students and campuses across the State to cover significant costs associated with a failing hospital, especially one that despite our best efforts does not serve our academic mission, the State's health care needs in Brooklyn, or the requirements of the federal Affordable Care Act.

"This is not about profits over patients, or a real estate deal, it is just the opposite. SUNY must exit LICH as part of a much broader plan to restructure Downstate so vital medical education and high quality care at UHB can continue."

Justice Demarest will be holding a conference on August 22 to address the return of assets to LICH and the future operation of LICH as a hospital.

# Commissioners Visit High-Tech Internship Program in DUMBO

New York City Small Business Commissioner Robert Walsh and Mayor's Office of Media and Entertainment Commissioner Katherine Oliver on Tuesday visited NYU Poly's tech incubator at 20 Jay St., DUMBO, to examine a summer internship program for City Tech students.

They spoke to two interns, business owners and others while touring the incubator space.

The DUMBO incubator is basically one large room with many workstations. It's similar to a typical office — with the difference being that the workstations, rather than belonging to different employees of the same company, are used by a wide variety of start-up companies.

Among these companies are Docracy, which provides free legal documents; Funding Community, a platform for small business loans; Violet

Health, which seeks to address the problem of anemia in pregnant women; Maker's Row, which connects manufacturers and product-based businesses; Brooklyn Bridge Ventures, a capital firm, and many more.

The two commissioners and several other city representatives first visited Bldg Blok, a startup that seeks to provide history-based apps for tourists from Brooklyn neighborhoods, starting with the Heights and nearby areas. "Exclusive content created in partnership with cultural institutions. Discover the city's history through curated photos and stories," reads the company's promotional material.

A shopping-related app is also in the works. "When tourists visit a city, one thing they love to do is shop," said Liz McEnaney of Bldg Blok.

They met the company's City Tech intern, Jennifer Ramos, who also works at the Brooklyn Historical Society. A professor at the school, she recalls, suggested that she apply. Like the other interns in the program (many of whom are also working in other parts of the "Brooklyn Tech Triangle"), she hooked up with her company through a mass "speed interviewing" session at the Brooklyn Navy Yard.

The next stop was Impact Solutions, which uses game-like techniques and video game technology to motivate employees. Stuart Silverman, head of the company, said it is currently targeting "hourly employees," mainly retail workers at "bricks and mortar retail. "

Silverman's City Tech intern, Donald Cherestal, who helped to organize and code much of the material, showed a chart illustrating how this would work. Employees play "games" that correspond to some of their work tasks. If they do them well, they get rewards such as a free hour off, a few hours of free park-

ing in the company's parking lot or a day shadowing one of the company's vice president.

Many retail chains think of semi-skilled hourly employees as disposable since their turnover is so great, said Silverman. But if the game technology made them more at ease and helped them stay even a few more months, it would save the

companies millions.

In addition to getting valuable experience, the internships can serve as "pipelines to employment," and the "speed interviewing" sessions help many of the internshone their interviewing skills, several of those present said.

### Brooklyn Shoot-'Em-Up

August 21, 1934 one of Brooklyn's biggest and most sensational holdups was reported on a front page EXTRA in the Brooklyn Daily Eagle. A huge headline read: "GUNMEN GET \$427,000 IN BATH BEACH RAID. EXTRA: Armored Truck In Machine Gun Duel with Gang. Bank Collection in Loot — 2 Bandit Cars Chased for Mile in Cropsey Ave. With Bullets Flying -Scores See Brooklyn's

Biggest and Most Sensational Holdup.'

The story: "Staging the biggest and most sensational holdup in Brooklyn history, a mob of from 5 to 15 machine gun bandits at 1 p.m. today hemmed in a U.S. Trucking Company armored truck in Bath Beach, cleaned it out, and made a breakneck escape \$427,000 in cash.

"The job was executed in front of the Rubel Ice Company plant in Bay 19th St.,

between Cropsey and Bath

"The holdup men worked with speed and precision, and less than three minutes were required for the daring coup.

"The escape was made with the bandits' two machines, one described as a new 16-cylinder Cadillac, roaring down Cropsey Ave. at between 60 and 70 miles an hour, with the armored car in pursuit for a mile and spitting machine gun shots at them.

"Scores of Rubel employes and from 10 to 20 tennis players disporting themselves on courts across the street from the ice plant witnessed the spectacle.

"Most were dazed by the sheer daring of the job, with the result that their descriptions of the bandits, their number, and their cars were sharply at odds.


#### Truck's Last Call

"The record loot represented collections that the car had made during the afternoon from branch banks in the Coney Island, Bath beach and Bensonhurst sections. The cash to be collected from Rubel's was the last to be called for before the truck returned to Manhattan.

"So heavy were the bags loaded with currency that the mob, quickly tossing their haul from the interior of the truck into the window of their car, left one bag behind. The bag contained \$29,000.

"Scram.' the tennis players heard the leader of the mob command as two were returning for the last sack.

'In an instant the mobsters were in their places in the machines and the cars roared into Cropsey, Ave., making the turn on two wheels with the armored car in pursuit for a mile, spitting machine gun bullets at them. The bandit's car was lost in heavy traffic."



#### Rev. Beecher On Trial BROOKLYN — On August

21, 1874 newspaper editor Theodore Tilton filed suit against Rev. Henry Ward Beecher for \$100,000, accusing the famous preacher of alienation of his wife's affections. Tilton claimed that his young wife, Elizabeth, grieving over the death of their son, had gone to her pastor's house for consolation and there "she had surrendered her body to him in sexual embrace; that she had repeated such an act on the following Saturday evening at her own residence ... that she had consequently upon those two occasions repeated such acts at various times, at his residence and at hers, and at other places ...

On trial, the Reverend Beecher admitted platonic friendship but denied adultery. The trial attracted national publicity and controversy. After a 112-day trial, the jury balloted 52 times and then gave up (with a vote of 9 to 3 in favor of Beecher). The hung jury saved Beecher and re-

stored him to his worshipful flock. A special investigating committee made up of members of his congregation, the Plymouth Congregational Church in Brooklyn Heights, had pre-

viously exonerated Beecher after interviewing 36 people, including Tilton. In spite of loyal supporters, the Louisville Courier-Journal branded him "a dunghill covered with

#### Angela and the Soledad Brothers

MARIN CO., CA — On August 21, 1971 George Jackson, 29, one of three black convicts known as the Soledad Brothers was killed in an attempt to escape from a Marin Country, California courtroom where he was being held for the 1970 murder of a guard at Soledad prison in California. Two convicts and three guards were also killed in the attempted mass breakout.

On August 7, 1970 a judge and three others had been killed in shootout in a San Raphael, California courtroom where George Jackson was on trial for the murder of a guard. During the trial a young black militant Jonathan Jackson, George's brother, entered the courthouse and opened fire in an attempt to free "The Soledad Three." Jonathan was killed in the shootout. (On March 27, 1972 the two remaining Soledad Brothers, John Cluchette and Fleeta Drumgo were found innocent by a San Francisco jury of the 1970 slaying of the guard).

Angela Yvonne Davis, championing the cause of black prisoners, grew particularly attached to the young revolutionary George Jackson. When rumored that Davis was a com-

munist, she was fired from her On This Day teaching job at In Brooklyn the University of California in History

Three of the guns used in the Marin County courtroom killings were registered to Davis. She was placed on the FBI's Ten Most Wanted List.

Arrested in New York City motel in October 1970, she was returned to California to face charges of kidnapping, murder, and conspiracy. In the Grand Jury indictment it was charged that Angela had purchased all the guns and had them smuggled into the courtroom by George's brother Jonathan. On February 2, 1971, New Yorkers held a tribute honoring Angela's birthday. There was a massive, international "Free Angela Davis" campaign. In 13 weeks of trial and testimony, the prosecution called 95 witnesses and presented 201 exhibits. After 13 hours of deliberation on Sunday, June 4, 1972, an all-white jury returned a verdict of "not guilty" on all charges.

While in prison George Jackson had written "Soledad Brother" (1970). And while Angela was in prison she wrote her first book in long hand. Since her release she has become a lecturer, and is co-founder of the still-active National Alliance Against Racism and Political Repression. She remains an advocate of prison abolition and is critical of racism in the criminal justice system.

# Brooklyn's 'Miracle Man' Scores KO Brownsville Native Jacobs Wins Headline Bout

Bloodied but certainly not beaten, Danny "The Miracle Man" Jacobs knew he had to dig deep Monday night at Manhattan's Best Buy Theater to re-establish himself as one of the middleweight division's top attractions.

The Brownsville native and cancer survivor did just that, shaking off a nasty cut under his left eye to score an impressive third-round stoppage of Giovanni Lorenzo in the headline bout of the new Golden Boy Promotions' Monday Night Fight series, telecast nationally on FoxSports1.

"I knew I had the skills over [Lorenzo], but I knew he had the experience," Jacobs admitted after improving to 26-1 with 23 career knockouts. "I know for a fact, he was getting me in the ring and trying these Bernard Hopkins moves, trying to get inside my head. I didn't let it get to me. I knew he was strong, but once he hit me with a good left hook, I said, 'OK, let's go."

Jacobs, who improved to a perfect 4-0 since overcoming a rare form of bone cancer that threatened his promising career as well as his life, saw blood in his eyes for the first time since his well-chronicled return to the ring.

He responded by stunning Lorenzo with a big left hook off the ropes, then finished him off with a thunderous right hand, forcing the referee to halt the bout at 2:05 of the third round.

"The Brooklyn came out of me," boasted Jacobs, who can now place his name alongside those of current middleweight champions Sergio Martinez, Peter "Kid Chocolate" Quil-



lin and Gennady Golovkin as mustsee fighters on the 160-pound circuit.

After scoring a pair of impressive victories at Barclays Center last October and this past June, Jacobs got his first taste of the big time in Times Square on Monday night. He was the feature attraction in what promoter Oscar De La Hoya hopes will be an early week staple on boxing fans' viewing itinerary.

But Lorenzo (32-6, 24 KOs) was eager to steal the spotlight from the

Brooklynite, drilling Jacobs with hard shots in the first two rounds until opening up the cut and landing a low blow that momentarily halted the proceedings in the third.

With his comeback, as well as his career, on the line, Jacobs found a way not only to navigate the assault, but to devastate his rival just over eight minutes into the biggest fight of his 26-year-old life — at least inside the squared circle.

"I wanted to make a statement and I felt I made a good statement tonight," Jacobs gushed with his new WBC Continental Americas Championship belt draped over his shoulder.

"I know Brooklyn came out in support and it fueled me," he added. "I know a lot of people are looking up to me because I'm a cancer survivor. I want to be inspirational to people. I want people to know that if you work hard, you can fulfill your dreams."

Up next for Jacobs is a likely return to the corners of Atlantic and Flatbush avenues in the next, as-yet-unannounced Barclays Center card.

#### In Brooklynite's New Novel, Small-Town Teens Rewrite Identities

Brooklyn-based writer Sarah Bruni's debut novel "The Night Gwen Stacy Died" is about small towns, sex, coyotes, and 1970s superhero comics. It is also about how girls and boys create their identities (secret and otherwise), escape small towns (via fantasy, car, crime), and write themselves into and out of stories in which, at first glance, they appear to be only minor characters.

On the cusp of 18, Sheila Gower has one friend ("she had always preferred the company of intense and loyal outsiders"), no plans to go to college (having grown up near one of the "more modestly sized Big Ten universities in the Midwest," she "felt she had already been to college and she really hadn't thought much of the experience"), and works nights in a gas station, where she studies French and plans to escape small-town Iowa for Paris.

In walks a slightly older boy with an I.D. (fake, she presumes) proclaiming himself to be Peter Parker, the alter ego of Spider Man. After her French teacher dashes her illusions of Paris, telling her that French people also have Burger Kings and thunderstorms and bills to pay, Peter offers her a chance to participate in his fantasy instead. Sheila thinks, "maybe this was one way to leave a place, with a boy and a gun" and agrees to road trip to Chicago, playing Bonnie to his Clyde.

Once on the road, Sheila discovers, to no one's surprise, that she has been cast as Gwen Stacy, Peter Parker's first love. She runs with it, embracing Gwen and Peter, in name, dress, and as a real-life romantic super-duo. Her lover-abductor has reasons of his own, stretching back to his boyhood, for choosing this particular plot. Being both too young and of a different gender than those typically obsessed with '70s-era Spidey comics, the lady playing his heroine doesn't know, at first, what any teenage comics geek does: Gwen Stacy will die.

But Gwen-Sheila is not Gwen Stacy. She seems to genuinely fall in love with Peter and finds that he makes her world bigger ("Peter made her want to talk to strangers. He made her think there was something to talk about – even in Iowa").

"Gwen Stacy never had a chance," writes Bruni. "She could never do anything but react to the elements of the story that befell her." But Sheila insists on an equal role in their story, telling Peter, "This thing we are together – you don't own it."

She improvises her lines, takes action, and rewrites the script. As she is told by a pack of possibly mystical and occasionally articulate coyotes who dog her throughout the story, "If you are reading the signs, you are writing the signs – they say what you see in them." From the elements of retro boyhood camp, teenage girlhood, and love vigilantes, Bruni forges a modern, subversive, original story of her own.

## 'Drinking Buddies' Director Thrives on Improvisation

Filmmaker Joe Swanberg is the first to admit that not all actors would want to work with him. "I love improvisation and there are some actors who don't," he told the *Brooklyn Eagle*.

Swanberg, whose new comedy "Drinking Buddies" opens Aug. 23 at the Nitehawk Cinema in Williamsburg, is famous in the movie business for his improvised, low budget films. He works without a script, just a basic outline, and asks his actors to improvise their scenes. It's a process that some actors thrive on and others shy away from.

"There are actors who like to disappear into a role. And I respect that. With improvisation, you can't hide. You have to bring a lot of yourself into it," Swanberg said in a phone interview on Aug 10

But for those actors who enjoy the process, it can be artistically rewarding. "It is a different challenge and actors like to challenge themselves," he said. His philosophy is to come to the set with an outline and nothing more. "I like the idea of setting the wheels in motion and then letting the actors own the characters," he said.

Swanberg, 31, who lives in Chicago, was in New York on Monday to promote "Drinking Buddies." Produced by Magnolia Pictures, the film stars Olivia Wilde, Ron Livingston, Jake Johnson and Anna Kendrick, who was nominated for an Academy Award in 2010 for Best Supporting Actress for her role in "Up in the Air," opposite George Clooney.

In "Drinking Buddies," Wilde plays Kate, who works in a craft brewery with Luke, played by Johnson. The two characters are just friends but would like their relationship to be something more. There are complications, however, as Kate is involved with Chris, played by Livingston, and Luke has a girlfriend Jill, played by Kendrick. Adding to the complications is that fact that Jill wants to know if Luke is ready to talk about marriage. When Luke and Kate unexpectedly find themselves alone for a weekend, the question of who should be with whom is comically explored.

Swanberg said he loved working with his four leading actors. "I'm hoping to work with them again," he added.

The idea for the film came out of his interest in craft breweries. "I have never worked in a craft brewery, unfortunately. But I am a home brewer and I am a participant in the craft beer scene Chicago," he said.

The characters played by Kendrick and Johnson are loosely based Swanberg and his wife, filmmaker Kris Williams, "from an earlier time in our relationship," he said.

"Drinking Buddies," like many of Swanberg's other movies, is about the ups and downs of relationships. The film was shot by cinematographer Ben Richardson, who also shot the Academy Award nominated "Beasts of the Southern Wild" in 2012.

Swanberg directed his first feature, "Kissing on the Mouth," in 2005. The following year, he made "LOL," starring Greta Gerwig, an actress he would work with again two more times, in "Hannah Takes the Stairs," (2007) and "Nights and Weekends" (2008).

The year 2010 was an amazingly productive year for the director. He made seven feature films: "Uncle Kent," "Caitlin Plays Herself," "The Zone," "Art History," "Silver Bullets," "Privacy Set-

ting," and "Autoerotic". The latter film was co-directed with Adam Wingard.

"I usually have about four or five ideas for films in my head. My wife gets jealous. She works on one thing at a time and completes it before moving on to the next project," Swanberg said.

On the set, Swanberg's working style is steeped in comfort. "My main goal on the set is to make sure the actors are comfortable and that they trust me," he said. He likes to maintain a fun atmosphere on the set. "We joke around a lot. I do my best work when I know everybody is happy and people can give of themselves," he said.

The thing he loves most about movie-making is the collaboration and leading a team of talented people all working toward the same goal. "The atmosphere of a film set by its very nature requires collaboration," he said.

Improvisation isn't for the faint-hearted. Actors have to think on their feet. But actors usually have the right instincts, Swanberg said. "If a scene isn't working, it's usually not the actor's fault. There's something wrong with the story line," he said.

Swanberg, who acts as well as directs, pointed to Joaquin Phoenix and Rosemarie DeWitt as actors he admires. He lists Mike Nichols, Elaine May, and Paul Mazursky as directors whose work he loves. And he's a friend and fan of Lena Dunham, the creator and star of the hit HBO series "Girls." "I just think what she's doing with 'Girls' is incredible." he said.

What advice would he give to someone starting out in the movie business? "Be weird and specific. Don't try to emulate other directors. Make something crazy; something only you could make," he said.

gage in the different activities, and all equipment, materials and laptops will be provided for the event.





## **Lhota to Democrats: Stop Attacking** Ray Kelly!

Democrats running for mayor are unfairly attacking Police Commissioner Ray Kelly in the wake of a federal judge's decision about the constitutionality of the stop-and-frisk policy, Republican mayoral candidate Joseph Lhota charged.

"I'm incredibly disappointed with my opponents in this race who continue to vilify Commissioner Kelly and the brave men and women of the NYPD rather than be honest with New Yorkers about how to keep our streets safe," Lhota said in a statement.

In another blast at Democrats, Lhota said they're criticizing stop-and-frisk while not offering any public safety policies of their own. "I have yet to hear a single answer from them about how they would effectively lower crime in the absence of proactive policing. Every New Yorker who is concerned about the direction of our city should take heed of their positions," he said.

Several of the Democrats running for mayor have stated in debates that that they would not keep Kelly on as police commissioner.

Lhota spoke out after Mayor Michael Bloomberg announced on Aug. 16 that his administration had filed an appeal of Judge Shira Scheindlin's decision. That same day, the New York Daily News reported that the mayor blasted the judge on his weekly radio show. "Think about this judge on stop-and-frisk," the mayor told listeners. "What does she know about policing? Absolutely zero," Bloomberg stated.

Lhota, the former Metropolitan Transportation Authority (MTA) chairman,

served as a deputy mayor in the Giuliani Administration. He is locked in a battle for the Republican Party nomination for mayor against billionaire political novice John Catsimatidis and George McDonald, founder of the non-profit group the DOE Fund. All three men have publicly denounced Sheindlin's decision on stop-and-frisk.

"I applaud Mayor Bloomberg for doing the right thing to protect New Yorkers' safety by appealing Judge Scheindlin's misguided decision on Stop, Question and Frisk," Lhota said.

"The flawed case was decided on misguided logic and a narrow scope of unsubstantiated evidence, and rightly deserves attention from a higher court," Lhota said.

The Wall Street Journal reported last week that Scheindlin ruled that while the stop-and-frisk policy in of itself was not unconstitutional, the manner in which the New York Police Department was carrying out the policy violated the civil rights of minorities who are stopped by police and frisked in disproportionately large numbers.

Scheindlin also ordered an independent monitor to come in and review the policy.

appeal will likely take months, added that if he is elected, he will pick up the ball from Bloomberg and see the appeal through. "As mayor, I will continue this appeal and ensure that our law enforcement has the tools necessary to keep all New Yorkers safe. In the meantime, I urge the courts to initiate a speedy process before we begin to feel the dangerous effects of a handcuffed police department," he said.

## SUNY Must Return LICH Assets, Brooklyn Judge Rules

Cites SUNY's 'Sinister Purpose'

Brooklyn Supreme Court Justice Carolyn Demarest found that the State University of New York Downstate (SUNY Downstate) violated a contractual obligation in the asset transfer of Long Island College Hospital (LICH) property and has ordered that LICH assets be transferred back to the hospital.

As previously reported in the *Brooklyn Daily Eagle*, in May 2011, LICH requested and was granted the opportunity to transfer some of its assets to SUNY. The order was granted under the express declaration that "SUNY Downstate will continue [LICH's] operation as a hospital."

SUNY has since then made clear its intent to close LICH and cease its existence as a functioning hospital, in direct contradiction to its 2011 declaration. In June 2013, Demarest ordered SUNY to provide an accounting of the property transfer and related monies in an attempt to ensure that the parameters of the 2011 order were being followed.

SUNY submitted the court-requested documents on Aug. 5, 2013.

SUNY's recent assertion that it must close LICH because of financial reasons — specifically that it is losing a significant amount of money by keeping LICH open as a functioning hospital and ER — did not persuade Demarest. In 2011, SUNY Downstate was "well aware of the deficit operating condition of LICH" at the time of the asset transfer, Demarest noted.

SUNY's reason for the transfer of assets was so that the monies

gained would allow SUNY to "minimize its costs and absorb the additional losses resulting from the operation of LICH" and therefore "avoid inevitable bankruptcy," said Democrat

After reviewing the records and documents in the case, Demarest no longer believed that the asset transfer was done to save LICH from financial decline. Instead, she concluded that the transfer had a "more sinister purpose to seize [LICH's] assets and dismantle the hospital."

Demarest lambasted SUNY Downstate in her ruling, declaring that there had been no "considera-tion provided by SUNY to LICH or the people of Brooklyn served by LICH," in its decision to shut down the hospital. She took the time to discuss the importance of LICH to the Brooklyn community, noting that "in addition to the approximately half million residents of the area served by LICH, virtually every citizen of Brooklyn and many others who are not citizens or residents of Brooklyn, who come into the downtown municipal center daily to work or litigate disputes or serve on juries, are served primarily by LICH in the event of a medical emergency."

Believing it her "legal and moral responsibility" to correct an "error," Demarest, without petition from LICH or any of its supporters, vacated the 2011 order granting asset transfer to SUNY and ordered that Continuum Health Partners Inc (Continuum), the "sole member of LICH" and former operator, take possession of the physical assets of LICH.

If, for whatever reason, Continuum is not deemed qualified, Demarest requested that a caretaker or receiver be appointed to take over the responsibilities of LICH's hospital administrator.

Demarest recognized that the "health care system, not only in Brooklyn, but throughout this city and this country, is in crisis," and cited hope that a feasible plan can be devised" to sustain LICH.

Public Advocate Bill de Blasio filed a motion on Tuesday in the Eastern District Bankruptcy Court, located in Downtown Brooklyn, to halt the closure of Interfaith Medical Center.

The motion asserts that the New York State Department of Health rushed in its approval of Interfaith's closure plan and failed to provide proper oversight by disregarding the 90-day review period as required under law. Interfaith is currently in bankruptcy proceedings and is slated to begin shutting down operations on Aug. 26.

In July, the Department of Health rejected a restructuring plan to save Interfaith. Interfaith, located in Bedford-Stuyvesant, subsequently asked a bankruptcy court to approve closure after the Department of Health rejected a restructuring plan and denied the hospital any financial assistance.

De Blasio's motion, if granted by the bankruptcy court, would lay the groundwork for a formal Article 78 lawsuit in State Supreme Court. An Article 78 proceeding allows a court to review the actions of an administrative agency, public body or officer to determine whether its decision was supported by substantial evidence, and whether the agency or public body failed to perform its duty or erred in the application of law or procedure.

As de Blasio prepares for a fight to save Interfaith, he appeared in Manhattan's Midtown Community Court on a disorderly conduct charge. De Blasio, along with Councilman Stephen Levin and a number of others, was arrested on July 10 during a protest at the midtown Manhattan office of the State University of New York in a protest to keep Long Island College Hospital, located in Cobble Hill, open.

## Brooklyn Federal Judge Finds Stop-and Frisk-of Parolee Illegal

A few days after Manhattan Federal Judge Shira A. Scheindlin's landmark stop-and-frisk ruling in Floyd, et al. v. City of New York, et al., a Brooklyn federal judge entered a ruling on Aug. 15 that the stopping and frisking of a Brooklyn parolee constituted an illegal search.

In the Floyd ruling, Judge Scheindlin ruled that the New York City Police Department's policy of stopping and frisking people who police officers reasonably suspect have committed or are about to engage in criminal activity has led to unconstitutional stops.

In the incident leading to the Brooklyn ruling, on April 4, NYPD Officers Konrad Zakiewicz and Salwa Jwayyed and Sgt. Kwame Kipp observed Ronald Mayo Jr. walking along a well-lit stretch of Marcy Avenue in Brooklyn. Zakiewicz reportedly told his colleagues, "I want to stop that guy," and he and his colleagues proceeded to do so.

When the officers stopped Mayo, they asked him to raise his hands above of his head. This revealed that Mayo had a firearm in the waistband of his pants, which was not evident before to the stop.

Mayo — son of Ronald Mayo Sr., who was sentenced to 16 years behind bars for running a Brooklyn drug distribution ring — was out on parole after serving four years in prison for felony assault.

"The seizure of Mayo by the police was unjustified," Brooklyn Federal Judge John Gleeson definitively ruled.

Officers Zakiewicz and Jawayyed testified that for a "split moment," a firearm was visible on Mayo prior to the stop and that they "saw something that appeared like the handle of a firearm."

Gleeson noted that Mayo was wearing a zipped hoodie and that the firearm was on the left side of his waistband. "Even if the sweatshirt was unzipped," Gleeson observed, "it would have draped down over the gun handle."

Furthermore, Gleeson noted, the officers' statement about observing a weapon prior to the stop had a number of flaws—namely that the complaint against Mayo did not mention Jawayyed's observation of a gun prior to the stop. In other words, Jawayyed did not state in the criminal complaint that he observed a gun in Mayo's waistband before he stopped him on Marcy Ave. The only time the Jawayyed noted that he saw Mayo's weapon prior to the stop was during testimony in the case.

Gleeson also discounted Zakiewicz's testimony and assertions. "A firearm on the scene is a big deal," Gleeson wrote in his ruling. Court papers show that Zakiewicz, who claimed that he saw Mayo's weapon, did not tell the other officers about it before the stop. It is common practice for the safety of others near the scene, for police officers to notify their colleagues when a weapon is present.

When questioned why he did not inform his fellow officers at the time, Zakiewicz said "Everything happened so fast," an excuse Gleeson discredited.

It was Zakiewicz who initiated the stop of Mayo when he told his colleagues, "I want to stop that guy," without any mention of Mayo's weapon or the reason he wanted to stop Mayo. "It doesn't

take much longer to say 'I want to stop that guy because he's carrying a gun' than it does to say 'I want to stop that guy,'" Gleeson wrote.

"Zakiewicz decided that he wanted to stop Mayo, but he had no lawful basis for doing so," Gleeson ruled. Therefore, Gleeson continued, "The observations of the firearm by the police were the result of the seizure, not its cause." Ruling that the stop was unlawful due to a lack of cause for the search, Gleeson held that the "firearm is the fruit of an unlawful stop and must be suppressed."

"The officers' testimony was inconsistent, unreasonable and implausible," Mayo's defense attorney, Chase A. Scolnick of Federal Defenders of New York Inc., told *the Brooklyn Daily Eagle*. Scolnick noted disappointment "in the officers' lack of candor while testifying under oath in federal court."

Gleeson was the same judge who sentenced Mayo's father in
